SCOPE

INITIAL REQUEST & ASSUMPTIONS

Business Statement

The business has determined that when Service Events are entered into FASAMS, the system should not look at the Admission's or Immediate Discharge's Contract Number to determine if the Service Event Contract Number is valid when the Service Event TypeCode is 1 (Client-Specific). Service Events Contract Number field should look at the Contract table directly for verification.

Each record entered into Service Event table (TypeCode 1 or 2) must have a corresponding parent record in the SubcontractService table. Hence, the Service Event record must include the SourceRecordIdentifier from the SubcontractService record.

Scope Definition

Update the Service Event entity to include a new SubcontractServiceSourceRecordIdentifier field, add new rules to match contract number and subcontract number to SubcontractService.SourceRecordIdentifier in SubcontractService table, and remove rule to submit Admission's or Immediate Discharge's ContractNumber if TypeCode is 1.

Update Provider Expenditure Reports as necessary.

EXISTING FUNCTIONALITY

The Service Event entity currently has a field called SourceRecordIdentifier. It also requires SubcontractNumber to be submitted and requires that the Admission or Immediate Discharge Contract Number be submitted with a service event.

PROPOSED FUNCTIONALITY

- Changes to Service Events
 - Add SubcontractServiceSourceRecordIdentifier field
 - Remove Rule: Must match the related Admission's or Immediate Discharge's ContractNumber if TypeCode is 1 (Client-Specific).
 - Update Provider Expenditure Reports as necessary
 - To reference SubcontractServiceSourceRecordIdentifier
 - Update uses of subcontract number
