### ORLANDO AREA REFUGEE TASK FORCE MEETING

#### **INTRODUCTION**

This task force meeting was held via conference call. Approximately 18 people were in attendance. David Draper, Community Liaison Manager, represented the Florida Department of Children and Families, Refugee Services (RS) Program. Rosa Chaves, Community Liaison for the Central Region, was also present. Everyone introduced themselves and the agencies they represented.

#### **GENERAL UPDATES/ ANNOUNCEMENTS**

- Sandra Algarin, Community Health Centers, stated that they recently opened a new center in Clermont, which covers three counties. At the center, they are providing internal medicine, pediatrics, and optometry. They have also opened COVID testing centers in Pine Hills and Apopka. These services are provided by appointment only.
- Anne Packham, Marketplace Project Coordinator informed the task force that special
  enrollments are being offered for clients who have lost their jobs and need insurance
  now. Open enrollment will begin in a couple of months. A flyer in Haitian Creole was also
  distributed to task force members.
- Vesna Bozic, USCIS Community Relations Officer, informed the task force that fees will
  be increasing on October 2. USCIS is also experiencing a furlough which has impacted
  many employees of the agency. Because of this, processing times for applications will be
  impacted.
- Wellington Ovalle, Department of Labor (DOL), stated that they are working on cases
  related to the Family First Coronavirus Response Act. They are ensuring that employees
  have the right to take sick leave when needed. If individuals have questions, they can call
  407-648-6471 or visit <a href="www.dol.gov/whd">www.dol.gov/whd</a>. There are staff members that speak multiple
  languages.
- Safriya King-Greenshaw, BAYS Family Connections Circuit 9 FFT Program Director
  informed the task force that they still have availability to serve more youth (ages 11-18).
  All services may be provided via Telehealth. The program is free of charge and no
  insurance is required. Spanish speakers are on site and services are being offered Monday
  through Friday.
- **Kirsty Ortega, Summit Church,** stated that they are distributing cards to recent refugee graduates. In coordination with AFCO, they also conducted a back-to-school event.

- Asli, Yalim, University of Central Florida, announced she is conducting a study to identify
  barriers refugees face when accessing health care services. She is currently searching for
  health care providers that are able to participate. She will send out an email with more
  information soon.
- Debbie Vega, Catholic Charities of Central Florida informed the task force that operations continue and that the lobby is open to clients. Generally, clients are seen via appointment. Catholic Charities is currently serving many Haitian and Cuban clients that recently arrived. They are working with many of these clients to help them obtain employment authorization. They are working with the social security office to ensure clients receive social security cards necessary for employment. The Catholic Charities refugee employment program are working with partner agencies to ensure clients are employed. The adult education program will begin providing in-person English classes on September 1. Virtual classes will continue to be offered. The Youth and Mentoring programs continue recruiting and training mentors and matching them with mentees. The Legal Program is working remotely (face to face meetings are by appointment only). Catholic Charities has also produced training videos in Creole and Spanish that are being used to help orient clients and connect them with important resources. Catholic Charities family stability program is also helping clients with rent issues in an effort to avoid evictions.
- Maria Diez, Catholic Charities Mentoring and Youth Program, and Rae Wilburn, Vista Program, are designing curriculum and attempting to recruit more mentors. Over the summer, they provided workshops and mentoring support groups. They brough in professionals from various careers to speak with the youth. They have worked with youth (especially those that are not technologically savvy) to ensure they were all connected with a computer and internet. Regarding mentor recruitment, background checks are taking a very long time (which is delaying mentor/mentee matching). Also, because of the pandemic, many mentors are reluctant to meet with mentees in-person. - David Draper, Department of Children and Families Refugee Services Community Liaison
  Manager stated that future task force meetings may be conducted via a virtual platform
  (Zoom or Microsoft Teams). Options are currently being explored. The DCF COVID 19
  webpage continues to be updated with important operational information. Clients eligible
  for P-EBT should have received their benefits. The governor's moratorium on evictions
  has been extended an additional month.
- Rosa Chaves, Department of Children and Families Community Liaison Central Florida stated that clients who needed to renew benefits in August are receiving an automatic extension through January 2021.
