SWFL REFUGEE TASK FORCE MEETING MINUTES

This meeting was held via Microsoft Teams due to the pandemic. Janet Blair, David Draper and Ileana Bustelo represented Refugee Services, Dept. of Children & Families (DCF). Forty people were present at the meeting which began at 1:04pm.

Presentations

The first presentation was from Christine McKee from the ESS (Economic Self Sufficiency) program at DCF. She shared plans for a new business model in 2021 which will be focused on customer care coordination. This new model is being piloted in other regions and will be coming to the Suncoast Region in early 2021. The second presentation was on the Micro Enterprise Development Program coordinated by Lorene Gregory from Gulf Coast Jewish Family & Community Services. This unique program is currently focused on providing loans and technical assistance to refugee and asylee women and is open to clients in the entire Suncoast region. Loans range from \$300-\$10,000 and a total of 10 refugee owned businesses have already been launched with 7-8 other clients in the pipeline. Shelly Randall, Field Office Director of the Fort Myers USCIS Office shared that the office is now fully staffed and continues to provide same-day naturalization ceremonies for all who pass their citizenship test. Lutheran Services Florida (LSF) Update

All offices continue to be open and working a hybrid schedule with staff alternating work in the office and work remotely. There has been a decline in new clients arriving in SWFL due to the pandemic. And LSF is looking at new ways to do outreach to former clients and let them know that they can still access services. The relationship with the Social Security Administration has been much better and over 50 clients from the Sarasota area alone are now working after receiving their new social security cards. Refugee Services Updates:

David Draper encouraged all attendees to continue checking the DCF website for updated information at <https://www.myflfamilies.com/covid19/>. He also shared that the White House has proposed a total of 15,000 new refugee arrivals for fiscal year 2021 but this declaration has not yet been signed. Approximately 250,000 asylees are also expected during this fiscal year. Florida expects to continue receiving both Cuban and Venezuelan asylees this year. Finally, he encouraged providers and community partners to work together to assist clients who may be struggling with housing costs and to link them with local resources as needed. Ileana Bustelo shared her appreciation for the ongoing work being done by both refugee services providers and community partners during this difficult year.

Additional Updates/Discussion

- Brian Granstra from Lee County Adult Education GED/ESOL shared that registration is now available at www.leeschools.net/ACE for the spring semester. Two-thirds of classes are being held virtually and open to anyone in the state of Florida. The cost for both in-person classes and virtual classes is \$30 per semester.
