# **INTRODUCTION**

The meeting was held via conference call with the Department of Children and Families Refugee Services Staff. Theresa Leslie who called the meeting to order.

## **PRESENTATIONS**

International Rescue Committee, Una Bilic, Site Manager presented program updates and current successes and challenges:

IRC reported that since the middle of March, all staff, interns, and volunteers have been working 100% remotely at home while assisting refugee clients through Zoom and What's App applications. They have also received re-training on job interview skills, completing job applications, hurricane preparedness, etc. Through employment partnerships with hotels and landscaping companies, some of the refugees are remain employed. IRC reported that an AmeriCorps Vista employee and summer interns are making calls to find other jobs for the other clients. Ms. Bilic reported that she will be filling the job vacated by the last Employment Case Manager.

IRC explained that many local refugees have approached the time when they can apply for citizenship. IRC will be working closely with them as they work to attaint his goal.

IRC also announced that a new AmeriCorps Vista volunteer started working for IRC and will work to build the capacity of the Refugee Mentoring program. This program will focus on refugee youth and young adults, ages 15-24. This new Mentoring program will stress civic and social engagement while also supporting each client's individual educational and vocational advancement. The program will be designed to give these individuals extra guidance and experiences that will contribute to a successful future.

# Legal Services of North Florida, Recent Grant Award

Cecille Lucero introduced herself to the Task Force explaining that she will be supervising and be actively participating in a new grant program entitled the Medical Legal Partnership at the Neighborhood Medical Center.

Tiffany Black, RN and an Executive Staff Member of the Center recommended that Ms. Lucero contact Refugee Services Community Liaison, Theresa Leslie about partnering with IRC as many refugees get their health care at this Center. She explained that they are in need of language accommodations, dental services, and often legal assistance.

Under the Medical Legal Partnership, this new grant will have a Case Manager on staff to assist eligible clients with their civil legal needs. The program will be further refined once the needs of the clients are assessed.

As stated on their web site Neighborhood Medical Center is the client's home for healthcare, providing Primary Care, Mental Health, and Dental services. They are the Big Bend area Federally Qualified Healthcare Center (FQHC) and a non-profit 501c3 organization. Materials such as brochures will be developed and will be accessible to the Task Force members and other community partners.

The Leon County Health Department announced that RoseAnn Sheck, MSW will now be representing the Health Department at the task force. Krissy Hamilton, the previous representative, is now in a new position. The Health Department reported that they have experienced budget cuts and are reducing staff.

**Lisa Urban, Leon County ESOL Schools Coordinator,** repeated her announcement of the installation of the Translation Line and the delivery of many training and teaching materials to be used in teaching and supporting ESOL students.
