## SWFL REFUGEE TASK FORCE MEETING MINUTES

This meeting was held at the Florida Department of Health located at 2200 Ringling Blvd in Sarasota. Janet Blair, Community Liaison, represented the Florida Dept. of Children & Families (DCF). Thirteen people were present and the meeting was called to order at 1:10.

### **PRESENTATIONS**

- The first presentation was given by Michelle Snyder from CareerSource Suncoast, which has
  offices in both Bradenton and Sarasota counties. In addition to their traditional offerings,
  CareerSource now also has a focus on soft skills and has free classes on career
  development, branding and 7 Habits for highly effective people. Key growth sectors in the job
  market include construction, IT, hospitality, electrical work and health care. Information on

- The second presentation was given by Grace Jean-Pierre from Centerstone Child Trauma Services. Along with mental health services for survivors of childhood trauma in Manatee, Sarasota and DeSoto counties, this program also offers training on Youth Mental Health First Aide and Trauma Informed Care. Both trainings are free of charge due to grant funding and can be tailored to each agency such as law enforcement or education or social services. For childhood trauma counseling, there is therapy offered in Spanish and the counselors are also willing to work with interpreters. - The final presentation was given by Elaine McArthur from the Equal Employment Opportunity Commission (EEOC). Elaine gave a brief overview of the employment rights of immigrants and what is classified as discriminatory action based on national origin. Elaine explained that although the online filing is only available in English, the EEOC has 150 languages available by telephone and can assist someone in filing. ### REFUGEE SERVCIES UPDATE

• Janet shared a brief overview from the Refugee Services Performance Review FFY2018, highlighting the information most relevant to SWFL.

### PROVIDER & COMMUNITY UPDATES

• There was some discussion regarding the SWFL Task Force's World Refugee Day event for this year. Last year's organizers cannot take on such a large scale event again and are

considering something on a small scale. A committee meeting will be held in late Feb. or early March.

- Shelly Randall from USCIS shared that more and more filings are available online and that starting March 4, 2019 info pass appointments will be geared to only what is necessary and most information will be found online. Shelly also noted that asylum applicants can check their status online and there are new online calculators to help clients see all fees required.
- The Lutheran Services, Inc. (LSF) Sarasota office manager, Ivis Triana, shared that LSF is seeing a lengthy wait for Employment Authorization Documents (EAD's) that is causing hardships on families due to the inability to work. She also shared that their current clients are almost 100% Cubans who are being given only one year paroles. An additional population in this area is Venezuelans who are moving to Manatee County/Bradenton. There are concerns about how to reach this population since the CareerSource and DCF do not refer Manatee clients since there is no physical office in that county. At this point, LSF Sarasota has over 215 active clients and the SWFL Comprehensive Refugee Services program has over 900 active clients as a whole.
- Elida Mujic, the Client Relations Coordinator for DCF in this area, shared that there are several upcoming office closures that will impact clients. The North Port, Naples and LaBelle DCF offices are all being closed this year. Providers and clients will need to utilize community partners for any in-person assistance. These updated community partners can be found at <u>www.myflorida.com/accessflorida</u> Users will need to go to the box at the bottom right corner labeled "Find Us", and then to a bullet that says "Search For A Partner Near You" which they will click on. Then they will see community partners listed by county or zip code. Some community partners will only serve their clients, so it is important to find one that is open to the general public.
