The Immigration Subcommittee Meeting was held on March 6, 2019 at the office of Church World Service. Berta Cassidy provided USCIS updates, Augusto Del Valle provided CBP updates, and Amanda St. Jean provided EOIR updates, followed by questions.

## <u>USCIS</u>

#### EXPANDING INFORMATION SERVICES MODERNIZATION PROGRAM:

As of March 18, 2019, the Information Services Modernization Program ends self-scheduling of Info Pass appointments and instead encourages applicants to use USCIS online information resources to view general how-to information and check case statuses through the USCIS Contact Center. Recent improvements to online tools provide applicants the ability to obtain their case status and other immigration information without having to visit a local field office.

**REVISED I-539:** USCIS has revised Form I-539, Application to Extend/Change Nonimmigrant Status, and will publish the revised form on our website on March 8, 2019. USCIS will reject any Form I-539 with an edition date of 12/23/16 or earlier that is received by USCIS after March 21, 2019. Starting on March 22, 2019, USCIS will only accept the revised Form I-539 with an edition date of 02/04/19.

Every applicant and co-applicant must pay an \$85 biometric service fee. Every applicant and co-applicant will receive a biometric service appointment notice, regardless of age, containing their individual receipt number.

**TPS:** The TPS designations for Sudan, Nicaragua, Haiti, and El Salvador will remain in effect, as required by the preliminary injunction order of the U.S. District Court for the Northern District of California in Ramos v. Nielsen, so long as the preliminary injunction remains in effect.

**MIAMI ASC OFFICE:** Be advised that the Miami ASC office has relocated as of February 19, 2019. The new location is at: **1620 NE 163<sup>rd</sup> Street, North Miami Beach, FL 33162.** 

### **CBP**

**FACIAL RECOGNITION:** U.S. Customs and Border Protection has rolled out the facial recognition biometric exit technology to all terminals at Miami International Airport (MIA). CBP will not be stamping any passports.

If the passenger is sent to Secondary, they will get their passport stamped.

Visitors and LPRs must get a CBP FOIA to obtain their travel history.

### **EOIR**

**JUDGES:** <u>Judge Ford</u> Has retired. Currently Judge Siegel is detailed at Broward Transitional Center.

Judge Siegel's Non-Detained docket has been reset.

Judge Riggs has relocated to Charlotte, NC. No Replacement yet.

**ISS:** DHS (USCIS, CBP, & ICE) now have access to DOJ Interactive Scheduling System. DHS can access the Immigration Judge's calendar and provide an actual date on the NTA. The asylum office will be provided a date.

#### **EDUCATION SUBCOMMITTEE MINUTES – APRIL 2019**

#### EDUCATION SUBCOMMITTEE MEETING

#### **April 12, 2019**

 REVEST is enrolling students for the upcoming first Mini Term of Summer 2195 from May 13 to June 28, 2019. So far around 1000 VESOL students are enrolled program wide in this current Mini Term 79.2 Spring 2193, and around 700 are going to be enrolled for the first Mini Term 80.1 for Summer Term 2195. Approximately 240 students have been scheduled to test in our Orientation Sessions throughout this month.

- The REVEST Program has been able to process 910 vocational registrations for the contract year. Previous Term Fall 2187 there were 464, Current Term Spring 2193 there are 385 and next term Summer 2195 we have 61 registrations. We continue providing training and advisement to advisors to be updated about changing procedures and system issues.
- Faculty meetings were conducted with all REVEST instructors Feb. 21, 23, 2019. All CASAS testing procedures were reviewed with instructors to ensure a successful testing session. CASAS testing is taking place April 16 -26, 2019. We expect completion rates to remain steady. All REVEST students were trained to employ basic test-taking skills. Our Wolfson and Hialeah Centers are now using the ECASAS computer-based test. We are very proud of the hard work of our determined faculty and especially our students.
- REVEST is offering ESOL classes through scholarships at Community Education (Miami Dade College) Kendall and West Campus. This is allowing clients to be served by REVEST in a broader range of sites. Our current sites in Hialeah and Wolfson are also offering classes and we are ready to serve clients. REVEST is monitoring progress of our eight-week courses and our mini-term system. We are also monitoring students receiving scholarships in the Kendall and West Miami Dade College sites.
- REVEST staff attended the USCIS training on adult citizenship education on April 11, 2019. This event was highly informative and educational. We were able to network with other providers in the community, review all processes from applying to interviewing and obtain new instructional techniques. REVEST appreciates this important support offered by USCIS.
- In SAVES, current trimester (2018-2) ends on April 12, 2019. The total enrollment in the SAVES program during this trimester is 1,284 This number includes 432 new clients and 60 Success Management Academy (SMA) GED clients, 16 18 yrs. old.
- The next trimester (2018-3) will begin on April 15, 2019 and will end on July 31, 2019. We are asking every provider to refer clients to the SAVES program. We offer English for Speakers of Other Languages (ESOL), General Basic Education, and a wide range of vocational/technical programs.
- The SAVES program continues to serve clients at 14 schools where SAVES
  representatives are housed. Two other schools, George T. Baker Aviation and Technical
  College and Miami Lakes Educational Center and Technical College, accept SAVES
  vouchers for referred SAVES clients. Eligible SAVES clients can take advantage and the

opportunity to attend classes and complete a vocational program that can lead to a successful career.

- SAVES continues to work closely with the M-DCPS Office of Public Relations, the Marketing Department, and SAVES schools to reach out to the community and disseminate information about the SAVES program. SAVES is currently advertising via mail-out, newspaper, radio, career fairs, and opening of school meetings.
- SAVES schools administrators and SAVES school contacts will continue to engage in a machine marketing campaign to recruit students by participating in open-houses and distributing flyers to the public at supermarkets, churches, and community agencies. They will continue to present at students' orientation and go on the public announcement system to promote their schools and the SAVES program. Many schools participate in the Viernes Culturales that is held at Calle Ocho the last Friday of every month. The English Center frequently publishes articles in newspapers and social media to promote the SAVES program.
- The SAVES Success Management Academy (SMA) program for students 16-18 years old continues to be implemented in seven SAVES locations. New procedures were established for 2018-2019 school year to ensure more student/parent involvement, empowerment, and participation. These procedures are paying huge dividends with higher completion rates and students' participation in higher education and vocational classes.
- SAVES continues to collaborate with other agencies in the community to provide additional services to the clients. On our next meeting to be held on May 29, 2019, the program director of the Unaccompanied Refugee Minors Program, Catholic Charities of the Archdiocese of Miami, Ms. Monica Farias, will present. SAVES is also collaborating with Career Source, Administrative Office, on a new referral program. Two representatives, Daniel Gilbert and Ibis Valdes, have been invited to present at the May 29th SAVES meeting.
- SAVES Students' success stories are shared at the SAVES District meetings and published on the SAVES website www.savesdadeschools.com. We invite everyone to read them.
- The next SAVES District meeting will be held on Wednesday, May 30, 2019, from 3:00 to 5:00 PM at Hialeah-Miami Lakes Adult Education Center. Please let us know if you would like to attend and share any information with SAVES school personnel.

## USCIS Miami & Caribbean District April 2019 Update

- ❖ Information Services Modernization On March 18<sup>th</sup>, the Information Services Modernization Program expanded to all Miami and Caribbean District Field Offices. This program ends self-scheduling of InfoPass appointments and instead encourages applicants to use USCIS online information resources and the USCIS Contact Center. As a reminder, individuals needing in-person service must make an appointment through the USCIS Contact Center at 1-800-375-5283. This includes individuals needing a stamp in their passport for travel/work, emergency advance parole requests, local filings and motions.
- ❖ Expanded Fee Payment System On March 18th, all Miami and Caribbean District field offices rolled into a new expanded fee payment system. Under this new payment system, we will only accept personal, attorney or business checks as well as debit/credit cards. Please note: this change only applies to locally submitted filings.
- ❖ Updated Forms We recently updated Form I-539, Application to Extend/Change Nonimmigrant Status and I-130, Petition for Alien Relative. Please visit our website at <a href="https://www.uscis.gov/forms">https://www.uscis.gov/forms</a> for the latest information on form revisions.
