### ORLANDO AREA REFUGEE TASK FORCE MEETING

#### INTRODUCTION

This meeting was held at Goodwill Facilities in Orlando (3911 East Colonial Drive, Orlando, FL, 32803). Approximately 27 people were in attendance. David Draper, Community Liaison Manager, represented the Florida Department of Children and Families, Refugee Services (RS) Program. Rosa Chaves, Community Liaison for the Central Region, was also present. Everyone introduced themselves and the agencies that they represented.

#### **SPECIAL PRESENTATION**

- I. Unites States Citizenship and Immigration Services (USCIS) Vesna Bozic/Community Relations Officer
  - Provided an overview of USCIS.
  - Focused part of the presentation on public charge rules and how enforcement could impact certain immigrants' ability to adjust status. Gave guidelines and clarification on who is and who is not impacted by public charge rules.
  - Informed the task force of a USCIS training occurring on October 24
  - Answered questions related to USCIS rules and regulations.

#### II. Primary Care Access Network (PCAN) – Anne Packham/Marketplace Project Director

- Provided an overview of the HealthCare.gov Marketplace and services.
- Explained that navigators are serving Lake, Orange, Osceola, and Seminole Counties. They have seen an 4% increase of enrollment in Florida.
- Stated that a high percentage of those enrolled do qualify for some financial assistance. However, thirty million people remain uninsured in the United States.
- Discussed program eligibility and gave general information about the program.
- Informed the task force that open enrollment will occur from November 1 through December 5, 2019.
- Answered task force questions related to Marketplace.

#### **GENERAL UPDATES/ ANNOUNCEMENTS**

 David Draper from DCF Refugee Services: David provided a recap of the Welcoming Week event that occurred in October. The task force began discussing plans to have a task force holiday 'pot luck' during the upcoming taskforce meeting. Information was shared on upcoming events sponsored by the Africans Family and Community Outreach organization (AFCO). David also mentioned that several Florida regions are transitioning into a 'Comprehensive Refugee Services model'.

- **Stephanie Walls from Florida Immigration Coalition** stated that the ceiling for refugee resettlement during federal fiscal year 2020 is 18,000.
- Fatima Ait Rami from Islamic Center of Orlando announced a "Week of the Family Event" event which will be organized with Orange County Florida. She also announced an Interfaith Community Barbeque occurring on Sunday, November 3, 2019.
- Ana Rios, Bethany Christian Services gave information on their Transitional Foster Care Program.
- Felipe Sousa-Matos Rodriguez, City of Orlando announced the Youth Empowerment Summit which will be taking place on October 19, 2019. The event is targeting youth between the ages of 18 and 24.
- Debbie Vega, Catholic Charities of Central Florida explained that they are negotiating a renewal contract with DCF Refugee Services. She stated that delays in the processing of employment authorization documentation by USCIS is impacting refugees' ability to work.
