#### SWFL REFUGEE TASK FORCE MEETING MINUTES

This meeting was held at the United States Citizenship & Immigration Services (USCIS) office located at 4220 Executive Circle Suite in Fort Myers, FL. Janet Blair, Community Liaison represented the Florida Dept. of Children & Families (DCF). Twenty-four people were present and the meeting was called to order at 1:15.

### **PRESENTATIONS**

- The first presentation was given by Max Maromontel from the Lee County Refugee Center Inc. This agency which is located in Fort Myers, focuses on assisting the Haitian population which Max says is estimated at 300,000 in SWFL alone. The Center provides both documented and undocumented Haitians with basic needs, legal assistance, temporary shelter, referrals and financial assistance. The Center is funded locally by faith communities and is looking forward to working closely with the Lutheran Services refugee program. - The second presentation was given by Shelly Randall of USCIS. Shelly said that the Fort Myers Service Center was almost completely staffed now and doing four citizenship ceremonies each week at this location. Between 400-500 people are being naturalized monthly at this branch and the backlog is decreasing. Saturday interviews are now available and there is a real emphasis on paperless filing. USCIS as a whole is in a reorganization period due to new executive orders and so some services have longer wait time than others. Info pass appointments are now being limited and there is a pilot project in Jacksonville that eliminates them entirely. After the meeting, a tour of the USCIS facility was offered to all task force members.

## **PROVIDER & COMMUNITY UPDATES**

- The SWFL Task Force's World Refugee Day event planning is underway and has gathered a great deal of community support. The event will be held on Friday, June 15<sup>th</sup> from noon to 2:30pm in Selby Auditorium on the University of South Florida Sarasota campus.
- Welcoming Week: Jacque Williams from the LSF Fort Myers office announced that the Welcoming Week event will be held on Sept. 17<sup>th</sup> and will include a luncheon with locally elected officials including the Mayor of Fort Myers. More details will follow.
- Janet shared that Refugee Services data for October 1, 2017 to April 30, 2018 showed a
  total of 87 new arrivals to Collier County, 95 arrives to Lee County and 48 arrivals to
  Sarasota/Manatee Counties.

- Denise Garbin from the DCF ACCESS program shared that they now only see 1-2 applications per day from newly arriving refugees/entrants due to the low number of arrivals.
- LSF continues to have a large client base at all three office locations due to the large number of arrivals in previous years. The key outreach tool being utilized is Textedly which allows LSF to stay connected to clients through texts rather than solely emails or phone calls. This communication has assisted in outreach and client retention.
