#### JACKSONVILLE AREA REFUGEE TASK FORCE MEETING

#### INTRODUCTION

The meeting was held at the Jacksonville Baptist Association. Taddese Fessehaye, Community Liaison Manager represented the Department of Children and Families (DCF), Refugee Services (RS) Program facilitated the meeting. There were 37 people in attendance. Dane Nelson, Contract Manager, Refugee Services Program, attended the meeting. The meeting was called to order and participants introduced themselves and the agency they represented.

Taddese announced that LeAndra Stafford was chosen to be the new Refugee Services Community Liaison for the Northeast Region.

#### **GUEST PRESENTATION**

Cristina Parcell, Operations Manager with Lutheran Social Services of Northeast Florida (LSS), gave an overview of all the programs and services within her agency. Departments:

- 1. AIDS Care and Education (ACE)
  - Heather Vaugh, Director
  - Has the leading suppression rate in the state of Florida
  - Offers case management services
  - Center Aids Network (CAN) has collaborated with LSS to open a Clinic in their old thrift store location. The clinic will consist of medical, dental, and pharmacy services.
- 2. Representative Payee Services
  - Michelle Euclid, Director
  - Rep Payee Services are offered to individuals not able to manage their money
  - The services have been extended to veterans and satellite offices are being opened for them.
  - Payments have become more streamlined for the participants
- 3. Nourishment Network
  - Jason Clark, Director
  - Serve seniors and students in Clay, St. Johns and Duval Counties.
  - During the hurricane they gave over 900 bags of food to Clay Co Schools, where
    the teachers would come to pick up the bags and distribute them to their students
    in need.
- 4. Refugee Services
  - Cristina Parcell, Director
  - Due to the new requirements for arrivals, Cristina believes the goal of admitting 45,000 refugees and 15,000 SIVs to the U.S. will not be met this year.
  - Their International Programs had a story featured in the Jacksonville Magazine Called "A Home Away from Home", about a family from Columbia who was resettled by LSS.

## REFUGEE SERVICES CONTRACTED PROVIDERS UPDATE

- World Relief (Jose Vega, Director):
  - o WR projected arrivals reduced from 220 to 200 for FFY 2018
  - o Received 5 Ukrainian refugees in December 2017
  - ORR site visit scheduled for Matching Grant (MG) program on Jan. 22 23
  - o Robin Koirola has replaced Meg Boot as the new IA Supervisor
- Catholic Charities (Michelle Karolak, Director):
  - o CCB projected arrivals are 92 for FY 2018
  - o CCB received a family of 4 in December 2017
  - ORR site visit scheduled for MG on Jan. 25 26 (this date may change due to scheduling)
  - ESOL (Michele Sanon, program manager), is encouraging all providers to send referrals for all new arrivals regardless of their English speaking ability
- Lutheran Social Services (Christina Parcel, Director):
  - LSS projected arrivals will increase from 170 to 220 for FY 2018 (due to some of LIRS affiliate offices closing in Florida)
  - o LSS received 6 refugees from Afghanistan in December 2017
  - $\circ$  ORR site visit scheduled for MG on Jan. 22 23
- **Legal Aid:** Mariana Munoz, has replaced Nancy Hale and is the new director of the Immigration Project.

#### **GENERAL UPDATES**

**Jaguar Foundation** – Shad Khan, owner of the Jacksonville Jaguars, donated 150 playoff tickets to refugees. These tickets were distributed between the three providers: LSS, WR, & CCB. The playoff package included tickets, transportation to the game, \$20 food voucher, a hat, and a towel for each participant.
