#### BROWARD COUNTY REFUGEE TASK FORCE MEETING

#### **INTRODUCTION**

The meeting was held at the Family Success Administration Division. Miriam Rosario, Community Liaison represented the DCF, Refugee Services (RS) Program. Miriam thanked the Family Success Administration of Broward County for hosting the meeting. The meeting was called to order and participants introduced themselves and the agency they represented.

#### SPECIAL PRESENTATION

A presentation given by Ruth Valenzuela, Program Consultant, Department of Highway Safety and Motor Vehicles, Bureau of credentialing Services, Division of Motorist Services. DHSMV shared some important updates and changes taking place with Driver licenses and ID cards. Starting in August 2017, the Florida Department of Highway Safety and Motor Vehicles will begin issuing a new, more secure Florida driver license and ID card. By the end of December 2017, the new credential will be available at all service centers throughout Florida and online. Previous driver license and ID cards will still be in use alongside the new credential until replaced or phased out.

#### **NEW ISSUES/ACTION TAKEN**

Wilber Roney, Senior Human Services Program Specialist reported on Disaster Food for Florida Program. He shares information on the Disaster SNAP program which will helped more than 7.5 million Floridians recover from Hurricane Irma. Due to setting up D-SNAP centers all over the state, ACCESS staff has been spread and temporary workers will be hired to assist at the DSNAP distribution cenetrs. However, ACCESS hours have been extended from 7:00am to 6:00pm to assist with this overflow. We shared important Federal Emergency Management Agency (FEMA) information and resources. #### **GENERAL UPDATES/ANNOUNCEMENTS:**

**USCIS**, Berta Cassidy indicated on a new partner she will be working soon. She briefly spoke about Haiti-the Temporary Protected Status (TPS) designation and the impact for Haiti and stated additional information should be soon. TPS for eligible nationals of Haiti (and eligible individuals without nationality who last habitually resided in Haiti) through Jan. 22, 2018. TPS beneficiaries who re-registered may request a new Employment Authorization Document (EAD). Additional information available- <a href="https://www.dhs.gov/tps">https://www.dhs.gov/tps</a>. Information appointment provided on the post-hurricane updates and all applicants who had interview scheduled during the hurricane period will be seen by the end November. Current delays on Info Pass and clients who had appointments will need to reschedule. He listed the upcoming outreach sessions and events at the Library Information Desk and USCIS. West Regional Library Broward County – Welcoming Week.: The RTF members and community partners and volunteers will work on an annual event. Mary Cassell, Librarian Senior West Regional Library provided information on this new partnership and all the services the Broward Library can provided to RS providers and clients.

RS Contracted providers: Project RENEW (PR) Clara Jarramillo with PR reported on their registration process for winter program. PR have two intake sessions, no GED in been offer during these sessions. PR is doing strong outreach and is asking the community partners for referrals. Church World Service (CWS) – Edele Firm discussed his Legal services and referrals process, The IA and Information and Referral program are actively helping many new arrivals specially in the Haitian community. Their Haitian community is experiencing delays in EAD and is been help by community and faith base organizations. Youth Co-OP, Inc. (YCI) - Gladys Sanchez and Jeanette Alban reported on their Vocational Career Laddering, Youth Program which offers GED and Career planning and Educational Path. YCI also offers Credentials/translations services. YCI is experiencing a decline in new intakes, and referral are welcome for those eligible with less than five years of arrival in the USA. Catholic Charities (CCLS)- Peterson St. Philippe Attorney from Catholic Charites Legal Services reported on EAD delaying to average of 4 months, The CCLS is diligently helping these clients and providing direct services and referrals to alleviate these delays. No additional updates.
