## **INTRODUCTION:**

Lourdes Leconte, DCF Refugee Services Community Liaison for the Southern Region welcomed everyone and called the meeting to order.

## **PRESENTATION:**

Amanda St Jean, Regional Public Information Officer, Office of Communications and Legislative Affairs, Executive Office for Immigration Review, U.S. Department of Justice in Miami provided an overview of the Executive Office for Immigration Review. The goal of the Office is to adjudicate immigration cases by fairly, expeditiously, and uniformly interpreting and administering the Nation's immigration laws. the functions of EOIR are essentially apolitical and doesn't arrest or detain, it doesn't set immigration policy and is not part of DHS/ICE. EOIR has three components: the Office of the Chief Immigration Judge (OCIJ); the Board of Immigration Appeals (BIA) and the Office of the Chief Administrative Hearing Officer (OCAHO).

OCIJ decides whether foreign-born individuals, who are charged by DHS with violating immigration law, should be ordered removed from the United States or should be granted relief or protection from removal and be permitted to remain in this country. DHS initiates removal proceedings when it serves the individual with a charging document, called Notice to Appear (NTA), and files the NTA with one of EOIR's immigration courts.

The immigration court then schedules a removal hearing, referred to as a "master calendar" hearing (there may be one or multiple), followed by an "individual" hearing, where both parties present the merits of the case.

At the conclusion of the case, the immigration judge usually issues an oral decision, but on occasion will issue a written decision sometime after the hearing. An individual's first hearing before an immigration judge varies by location. In the detained setting, time from the DHS filing of a charging document with the immigration court to a first hearing is an average of approximately three weeks; in a non-detained setting, that average is approximately 12 weeks.

The BIA is EOIR's appellate component. BIA is the highest administrative body for interpreting and applying immigration laws; which primarily decides appeals of immigration judge decisions. Certain BIA decisions that the BIA designates as precedent decisions apply to immigration cases nationwide.

OCAHO hears cases that relate to 1) Employer sanctions for illegal hiring of unauthorized workers, 2) Document fraud, and 3) Unfair immigration-related employment practices. Unlike criminal courts, respondents in immigration court are not authorized attorney representation at taxpayer expense (except for special situations like respondents found to be mentally incompetent or unaccompanied children).

EOIR's Office of Legal Access Programs oversees a number of initiatives to help ensure that respondents understand their rights and have access to no-cost or low-cost representation, if it is available in the community. EOIR also works to assist free legal clinics at local law schools, local non-profits, and attorneys who wish to volunteer a portion of their time as pro bono counsel. EOIR's immigration courts are open daily to the public, with limited exceptions. EOIR's Office of Communications and Legislative Affairs would be delighted to coordinate your visit.

Discussion on current situation and the effect of SCOTUS decision. Discussion on the meaning of bonafide relationships and agencies tie to allocated clients. Agencies are not "bonafide" relationship. Both State Department and DHS are looking for "strong US Tie Relationship" so documentation proving tie is needed.

SIV recipients continue to be allowed entry. They are not counted in the refugee ceiling of 50,000. As of June 23<sup>rd</sup>, 48856 refugees had entered the US. It is estimated that refugee ceiling will be reached by July 12<sup>th</sup>, if not sooner. Agencies continue to discuss office restructuring amid uncertainty of refugee program hold of 120 days.

FY 18 Reception and Placement future

Discussion of Refugee program for FY18 ensued. Uncertainty tied to both the US Supreme Court ban review taking place in October, along with Presidential Determination numbers.

Agencies continue to have same projections as submitted to State during consultations. Additional information regarding advocacy campaigns revolving around refugee program are pending.

# EDUCATION SUBCOMMITTEE MINUTES – AUGUST 2017

## EDUCATION SUBCOMMITTEE MEETING August 11, 2017

- REVEST is enrolling students for the upcoming term beginning September 6, 2017 and ending December 22, 2017. So far over 3000 ESOL students have been enrolled program wide. Approximately 1250 have been tested and more orientations are planned. So far, 36 Orientation sessions have been scheduled. For current Cycle 74 the enrollment is 2173, and for Cycle 75 is around 3055.
- The REVEST Program has successfully finished vocational registrations for the current Term Summer 2175, thus completing the current contract year with the highest quantity of registrations in the Program's existence. We have been able to serve over 700 students registered in around 1300 courses until August 2017.
- REVEST has already started CCC and CTEC registrations for the Fall 2177 beginning on August 28th, 2017, and we have already served over 60 new students.
   We continue to hold Vocational retraining sessions for advisors based on the new changes in the MDC Information System.
- Faculty meetings were conducted with all REVEST instructors July 27,28, 2017. All CASAS testing procedures were reviewed with instructors to ensure a successful testing session. CASAS testing is taking place Aug. 9,10,11, 2017. We expect completion rates to remain steady. All REVEST students were trained to use scantrons and employ basic test-taking skills. We are very proud of the hard work of our determined faculty and especially our students.
- World Refugee Day was celebrated on Wednesday, June 14, at Miami Dade College's Wolfson Campus. Festivities included presentations, a panel discussion, and a concert that highlighted the contributions of refugees to this nation. Refugee services organizations were present to assist and provide information. We would like to thank all involved that made this special event possible.
- The total SAVES Program enrollment as of June 23, 2017, was 4,246. Of these, 1,503 are new students to the program, and 429 (100 more students than last meeting) are 16 to 18 youngsters enrolled in the SAVES GED in Spanish Program. Graduations were held

at the end of the term. This program has proven to be an excellent alternative for refugee youth that would otherwise not make it in the regular high school programs. Students are graduating and continuing to study English and choosing a career pathway either through vocational/technical training or transitioning to MDC.

- The next trimester begins on August 21, 2017 and ends December 22, 2017. Schools are open for registration.
- Vouchers Students that are ready for vocational/technical programs that are not offered at the current school they are attending (i.e., Baker Aviation, Miami Lakes Tech College) are being issued vouchers for books and tuition.
- Marketing/Student Orientations SAVES is working closely with the M-DCPS marketing department to reach out to the community and get the word out on our programs. We are currently advertising via newspaper, radio, career fairs, opening of schools meetings, renovated website, etc.
- SAVES preliminary performance results for term 2016-2 (January 9 April 7, 2017) are as follows: PSAV OCPs earned: 63% (45% contract requirement) ELI Completers: 64% (40% contract requirement) ELI LCP's earned: 51.24% (40% contract requirement). SAVES surpassed all contract goals. We are very proud of these results and most of all for our students' achievements and performance.
- The GED in Spanish program continues to grow and is now available in 10 schools around Miami Dade County: 1) Hialeah-Gardens SHS, 2) Westland Hialeah SHS, 3) Hialeah Adult Education Center, 4) Hialeah-Miami Lakes Adult Education Center, 5) Miami Springs Adult Education Center, 6) Robert Morgan Educational Center and Technical College, 7) Southridge Senior High (Palmetto Adult); and 8) Miami Coral Park Adult Education Center. It is also offered at 9) Booker T. Washington and 10) Miami Jackson Senior High School where the student population is the unaccompanied minors. Total combined enrollment (SAVES and Non-SAVES youth) is over 600 students. Another school (TBA) in the south end of the county will soon offer the SMA program.
- New SAVES success stories, which highlight the achievements of some of our students, have been uploaded to the SAVES website (<u>http://saves.dadeschools.net.</u> In addition, two success stories posters were published and they are displayed throughout the county.

# July 2017 Update

- REMINDER Haitian TPS Re-Registration Period Ends Soon Temporary Protected Status (TPS) for eligible nationals of Haiti has been extended through Jan. 22, 2018. Current beneficiaries must re-register by July 24, 2017.
- New I-485 USCIS has revised Form I-485, Application to Register Permanent Residence or Adjust Status. The new edition is dated 6/26/17. Beginning August 25<sup>th</sup>, USCIS will only accept the new edition and will no longer accept earlier versions of the form.

**Please note**: You are NOT required to submit Form I-693, Report of the Medical Examination and Vaccination Report at the time you file your adjustment application, but may do so if you wish. Because of the time-limited validity of Form I-693, you may choose to submit your Form I-693 after you file your Form I-485. You may also submit Form I-693 in person at an interview in a USCIS field office, if an interview is required. By waiting to submit Form I-693, you may avoid having to repeat the immigration medical examination.

- Local Leadership Update Beginning July 17<sup>th</sup>, Linda Swacina will serve as the USCIS Acting Southeast Regional Director for 120 days. During this timeframe, Steve Koch will serve as the Acting District Director and Eileen Lopez-Tome will serve as Acting Deputy District Director of the Miami and Caribbean District.
