The VOLAG meeting was held at Church World Service on April 6<sup>th</sup>, 2016

Jose Sanchez called the meeting to order and welcomed everyone. Agenda were reviewed and approved. Minutes from last meeting were approved and submitted to the State in March.

Youth Coop shared with the group an email received from ORR that indicates that non Cuban born children from both Cuban national parents are eligible to receive ORR benefits including the participation in the Matching Grant program as long as they reside in the same household with their parents. Refugee Services mentioned that those non Cuban born children remain ineligible to receive benefits with the State such as Medicaid, Cash and Food stamps.

VOLAG reported refugee arrivals to be very slow. Agencies reported that most of refugees arriving are without US ties and are coming from DRC, Colombia, Eritrea, and Cuba. Agencies reported very low numbers of Cuban refugees arriving comparing to past years.

CWS reported last minute cancelations of refugee families scheduled to arrive due to the inability to obtain exit permits from countries of refuge and due to medical reasons.

Jose Sanchez raised concerns with the Refugee Health Assessment program in Miami Dade in regards to the appointments given to refugees to receive the initial medical screening and additional follow ups. Some of the refugees have been scheduled to receive the services on Saturdays, others at 7:00 am and some others are scheduled late appointments to see pediatricians.

Jose Sanchez will be contacting the Refugee Health Assessment Program and will report the outcomes in the next meeting. Participants reported the same concerns.

#### • CAM Program updates

WR reported over 100 applications filed under the CAM Program. WR has received about 10 refugee children, most of them with paroles and ineligible to receive refugee resettlement assistance.

#### **Parolee Orientation (POP)**

Jose Sanchez (CWS) reported that Cuban and Haitian parolees arriving through the family reunification program are receiving the flyer with the information about the CWS and USCCB Parolee Orientation Program (POP) in Havana and Porto Prince respectively.

Jose Sanchez reported the numbers for the POP:

March 2016: 297 Cuban parolees – 32 migrated out of the State and 29 out of Miami Dade County.

March 2016, 124 Haitian parolees – 79 migrated out of State and 34 out of Miami Dade County.

YTD – Cuban Parolees – 672 Haitian Parolees – 228

#### **Asylum Office Power Point Presentation schedule**

Resettlement agencies have been participating in the presentations at the Miami Asylum Unit with the DCF Office of Refuge Services. DCF – RS attends all the sessions and resettlement agencies attend on a rotating basis. May: WR, June: Youth-Coop and July: CWS. Jose Sanchez reminded everyone to report the inability to attend ahead of time in order to find a back uop agency to guarantee VOLAGs' participation.

• Other Items / Announcements

**Charlande Michel from EMM** raised a concerned with DMV regarding the delay for non-Cuban refugees that have applied for their Driver License. These clients are not receiving proof of applications and their process is taking longer than usual. She will elevate a complaint to a supervisor and will report the outcome back to the group during next meeting.

**Jackie Carrion from Catholic Charities** announced their new Health Grant available for Parolees, Asylees, Cuban Entrants, and Victims of Human Trafficking. They are going to provide 4 hour sessions on Health, Mental Health and support groups. They are willing to provide these trainings at individual agencies if requested as long as the group of participants is larger than 20.

Ana Maria Teixeira from IRC also announced the ICM (Intensive Case management Program) available for single parent, mental health, victim of gender-based violence, LGBTQI, elderly, unaccompanied minors, Congolese, or secondary migrant. (Information flyer was provided at the meeting).

The Immigration and Legal Issues Subcommittee meeting was held on April 7, 2016 at the offices of Church World Service, Inc. (CWS) where Berta Cassidy provided the USCIS update and Veraliz Cotto provided the Miami Asylum Office update, and they answered questions as follows:

- CITIZENSHIP AND INTEGRATION GRANT OPPORTUNITY. A reminder that USCIS is accepting applications for two competitive funding opportunities under the Citizenship and Integration Grant Program for fiscal year 2016. - EMMA. USCIS launched Emma, their computer-generated virtual assistant in English in December, 2015. They are getting ready to launch Emma in Spanish. They are looking for volunteers to take a few minutes to ask Emma USCIS-related questions in Spanish. - CHANGE OF VENUE TO HOLD FUTURE MEETINGS. All members who were present at the meeting came agreed to hold the Legal Subcommittee meetings on the first (1<sup>st</sup>) Wednesday of the month alternating venues every other month with Church World Service and Americans For Immigrant Justice.
- MIAMI ASYLUM OFFICE. The Miami Asylum Office did not have any updates to announce. #### **EDUCATION SUBCOMMITTEE MINUTES – APRIL 2016**

#### EDUCATION SUBCOMMITTEE MEETING

**April 8, 2016** 

- REVEST is enrolling students for the upcoming term beginning May 11 and ending Aug. 27, 2016. So far over 2900 ESOL students have been enrolled program wide and more are expected. Approximately 1400 have been tested and we expect to test 240 additionally. Demand continues to grow for on opportunity to receive VESOL and Vocational classes.
- The REVEST Program has steadily continued to increase the number of vocational registrations, so much so, that the demand of requests has exceeded our budget.
   Consequently, we have successfully begun new registrations for the Summer Term (2015-3), and they will extend to the end of our contract year in August. Our staff receives ongoing training sessions as a way to improve the process and be up to date with the new challenges.
- Faculty meetings were conducted with all REVEST instructors March 24 and 25, 2016.
   All CASAS testing procedures were reviewed with instructors to ensure a successful testing session. CASAS testing is taking place April 6<sup>th</sup>, 7<sup>th</sup> and 8th, 2016. We expect high completion rates.
- The total SAVES Program enrollment as of April 1, 2016, is 4,465. Of these, 2,674 are new students to the program and 257 are 16 to 18 youngsters in the six SAVES centers offering the GED in Spanish Program. The current trimester ends on April 21, 2016. The next academic trimester will begin on April 25, 2016.
- SAVES performance results were published by DCF for the fall term 2015 1. SAVES surpassed all contract goals. We are very proud of these results.
- A SAVES District meeting was held on March 30, 2016. Important information was discussed with the school staff. Next SAVES District meeting is scheduled for May 25, 2016.
- Ms. Marisol Martin and Ms. Paulina Velez from Career Source South Florida attended the SAVES District meeting held on March 30, 2016. They shared information on additional benefits and services available for the SAVES students. Ms. Sonia Granados from Catholic Charities also attended the meeting and provided information related to unaccompanied refugee minors. SAVES is collaborating with Career Source and Catholic Charities to share information and bring additional benefits to SAVES students. We would like to thank them for their presentations.
- SAVES is collaborating with the Miami-Dade College REVEST program to assist students who completed their GED and are interested in pursuing a college education. M-

DC will provide counseling services to students to help them with registration, applying for financial aid and mapping their career goals. M-DC counselors visited Miami Coral Park Adult Education Center and met with 21 youngsters 16 to 18 years old in the GED in Spanish program. The counselors provided assistance on completing a college application, courses available, requirements, counseling, and application for financial aid. They are scheduling visits to Miami Springs and Hialeah-Miami Lakes Adult Education Centers in the near future for the same purpose.

- A Degree Translation/Validation session will be held on April 12, 2016. Twenty three (24) students have been scheduled to attend the session to receive this service. The next Degree Translation/Validation session will be held on May 26, 2016
