Meeting participants also receive updates, information and clarification on new federal and state regulations and policy changes pertaining to refugees. #### TAMPA BAY AREA REFUGEE TASK FORCE MINUTES

Mission Statement: Helping Refugees to settle, integrate and thrive through support, education and community.

This meeting was held at the Department of Children & Families located at 9393 North Florida Ave, Tampa, Florida. Patti Grogan, Director of Refugee Services and Janet Blair, Community Liaison for the SunCoast Region represented the Department of Children and Families (DCF). A total of 56 were present during this meeting. Janet called the meeting to order at 1:35pm and Patti led participants in the Pledge of Allegiance.

#### **Presentations:**

- A presentation was given by Sunny Hall from The Crisis Center of Tampa Bay. The Crisis Center of Tampa Bay is a community partner of the Task Force and working closely with the mental health subcommittee to insure that clients are receiving trauma informed services. Sunny reminded Task Force members to dial 211 for a wide range of services. Basic services include suicide prevention, care coordination, follow-up and referrals. Veteran services are available. Other services provided include sexual assault exams and counseling. Services are provided in a linguistic and culturally appropriate manner. All services are available 24/7. The center has trauma informed care, voice and choice. One to five days is the typical response to non-urgent referrals and requests.

- A second presentation was given by the staff of Radiant Hands, led by Magda Selah. Radiant Hands has been partnering with the Task Force since October, 2015. As a nonprofit and locally funded program, Radiant Hands offers a wide range of services to over 100 refugee families with the goal of helping them become self-sufficient and integrated into the community. Radiant Hands focuses on assisting clients identifying as Muslim, but will help all refugees regardless of their faith affiliation. Radiant Hands staff work closely with the four local resettlement agencies to provide various services for clients. For example, they provide a "Welcome Basket" which includes prayer rugs, tea, and culturally appropriate hot meals, used furniture, linen, dishes, utensils, etc. all of which is donated from community members and given to new arrivals. Radiant Hands staff also provide job referrals and counseling services as needed and 3 months of paid phone service. Staff and volunteers speak a variety of languages including Arabic and Farsi. Additional services include providing training for women to get jobs who have never worked in their native countries and assistance with relocation to another state if necessary. ## **Refugee Services Update:**

 Patti Grogan gave an update on refugee arrivals statewide—as of April 2016 a total of 24,925 have arrived to the state for an average of 5,000 arrivals per month. Ninety-five percent of these arrivals are from Cuba and many of them are joining family members already residing in Florida. Many Cubans are crossing the border after going through Central America on a perilous and difficult journey. Refugee Services is focused on helping these new arrivals to find employment and 12,000 were placed in jobs last year. This year the employment numbers will be even higher. Other populations we expect to see in Florida this year include Congolese and some Syrians. Burmese resettlement has come to a close.

- Janet Blair and Doug Haskitt gave an update on this year's World Refugee Day event which will be held on June 17<sup>th</sup> at Pinellas Technical College in St. Petersburg, FL. This year's event will include a citizenship ceremony, awards for faculty and students of Pinellas County Schools and a screening of the film "Refugees: Roads to Success."
- Janet also announced that the Tampa Welcoming Week event will be held on Saturday, September 17th at the University of South Florida and is being sponsored by the Honors College and Pacific Interpreters. This second annual event will include a cultural festival and a planning committee is already hard at work to make this year's event even more successful than last year. ### **General Updates**

**United States Citizenship & Immigration Services:** is partnering with both the Tampa Bay and SWFL Task Forces to conduct citizenship ceremonies for World Refugee Day in two locations.

**Adult Education:** The CARIBE Tampa program is partnering with University of South Florida on several initiatives, one of which is an oral history curriculum that will be created by sharing stories of local refugees and then developed by college and graduate students into a 4<sup>th</sup> grade curriculum that can be utilized by ESOL programs county wide.

**Project Prosper:** It was announced that April is financial literacy month and that Project Prosper now has capacity to generate loans to 20 individuals at a \$1,500 maximum loan amount.

**Global Community Church**: Pastor Joseph announced that he will open a summer tutoring program for elementary school students this summer at his church.

**Hillsborough County Government**: Hillsborough County is hosting the first annual Diversity Festival on Saturday, April 16, at 601 E. Kennedy, 11 AM-3PM, Indian groups, Asian participants, Special Olympics gymnastics, diverse foods available. For more information call 813-276-8401.

**University of Tampa/UN-USA Tampa Chapter:** A Human Rights Day event will be held on April 23<sup>rd</sup> at the University of Tampa that is free and open to the public to attend.

This is a voluntary organization and they are currently filing for nonprofit status.
