EXECUTIVE SUMMARY

The passage of Senate Bill 1326 by the 2020 Florida Legislature, along with the support and signature of Governor Ron DeSantis, codified the Department of Children and Families' first Quality Office. This new approach to focusing on the quality of services provided has already paid dividend in systemic collaboration. Moves toward prevention, and increased insight into the work of frontline team members. As part of the implementation of SB 1326, also known as the DCF Accountability Act, the department asked the seven designated sheriff's offices conducting child protective investigations to take a close look at how they can impact prevention and diversion from deep-end services. The department greatly appreciates the partnership of the sheriffs' offices and is proud to see outcomes already improving, including a reduced removal rate in both Broward and Pinellas counties.

This 20th Annual Sheriffs' Peer Review Report complies with section 39.3065(3)(d), Florida Statutes (F.S.), concerning quality performance, outcome-measure attainment, and cost efficiency. Typically, a team of peer reviewers from sheriffs' offices and the department complete casework audits on closed investigations as a component of the annual evaluation. Due to the changes being implemented as a result of the Accountability Act, as well as the global COVID-19 pandemic, the peer file review was postponed to the spring of 2021. Data collected will be presented in the report next year.

The seven sheriffs' offices conducting child protective investigations (Broward, Hillsborough, Manatee, Pasco, Pinellas, Seminole, and Walton) encompass metropolitan areas where more than a quarter of the state's child population resides. A total of 183,259 child protective investigations were conducted in Florida during FY 2019-20¹ and the seven counties where sheriffs' offices handle investigations conducted 44,685 (24.38%) of the state's investigations. The longstanding commitment of the sheriffs' offices involved in child protective investigations toward engaging families, protecting children, and working in partnership within their communities remains consistent and strong. They are an essential partner in moving forward with shared values, principles, and efforts the department seeks for enhancing Florida's child protection system.

With the implementation of the Quality Office, monitoring instruments have been revised to include Life-of-Case Reviews that occur at designated key points during open investigations. The review is conducted on open cases to allow for real-time adjustments, if needed, to change the course of an investigation to ensure child safety. The annual peer review will use the same monitoring instrument for a statistically significant sample of investigations closed during the prior year. The review teams will consist of members from each Sheriff Office and representatives from the department to increase consistency across each review site.

Section 39.3065(3)(b), F.S., requires sheriffs' offices to operate in accordance with performance standards and outcome measures established by the legislature. Child protection and child welfare outcomes are established in section 409.986(2), F.S. Both measures listed below are included in the sheriffs' grant agreements:

- Percent of investigations commenced within 24 hours: Target 99.5%.
 - o Department performance: 99.53%
 - Sheriffs' office performance: 99.48%
- Percent of victims seen within 24 hours of receiving a report: State target 90%, Sheriff Target: 85%
 - o Department performance: 93.03%
 - o Sheriffs' office performance: 92.13%

SECTION I: SHERIFFS' INVOLVEMENT IN CHILD PROTECTIVE INVESTIGATIONS

Sheriffs' offices in Broward, Hillsborough, Manatee, Pasco, Pinellas, Seminole, and Walton counties are authorized under section 39.065, F.S., to conduct child protective investigations in their respective counties. Upon receiving a report of known or suspected child abuse, abandonment, or neglect, or that a child is in need of supervision and care and has no parent, legal custodian, or responsible adult relative immediately known and available to provide supervision and care, the Florida Abuse Hotline accepts five types of child intake reports:

- 1. In-home reports alleging maltreatment by a child's caregiver
- 2. Institutional reports alleging maltreatment of a child by another person responsible outside of the child's caregiver (i.e., incident at school, childcare facility, etc.)
- 3. Child-on-child referrals alleging inappropriate sexual behavior or an alleged juvenile sexual offense
- 4. Human Trafficking allegations
- 5. Special condition referrals that include Parent Unavailable, Parent in Need of Assistance (PNA), and Foster Care Referrals

The Florida Abuse Hotline is required to refer allegations of criminal conduct to the law enforcement agency of the municipality or county in which the alleged conduct has occurred. These criminal allegations are not considered child protective investigations and, therefore, are not included in this report.

Child Population

During FY 2019-2020, 27.64% of Florida's child population resided in a county where the sheriff's office performs child protective investigations. The seven sheriffs' offices received 24.38% of initial and additional reports and special condition referrals. This totaled 44,685 reports and special condition referrals for the respective sheriffs' offices.

Monthly data on the reporting rates (initial and additional reports) received per 1,000 child population show a general increase year to year. However, COVID-19 significantly affected the reporting rates for 2019-2020. With less children in school and visible by teachers and school personnel, one of the largest groups of mandatory reporters, they were no longer able to identify early warning signs of abuse and/or neglect.

Initial and Additional and Special Condition Reports

Of the 183,259 child investigations and special condition reports received in FY 2019-2020, there were 148,808 initial intake reports, 13,980 additional intake reports, and 20,471 special condition intake reports.² There were 29,549 less reports in FY 2019-2020 than FY 2018-2019, largely due to the COVID-19 pandemic that began impacting reports in April 2020.

² Each sheriff's office also handles various requests received from other states and/or other counties for child protective investigative assistance. Most requests include obtaining records, conducting a child-welfare check, verification of information, emergency home studies, etc. The work volume associated with such in-state requests (also known as "out-of-town inquiries" or OTIs) and inter-state requests varies from county to county but is estimated by the sheriffs' offices to account for an average of ten percent of incoming casework assigned to child protective investigators. These requests for assistance are not officially tabulated or captured by the department as a workload element when capturing active caseloads.

Incoming Reports and Special Conditions by Type by County

The tables on the following pages provide data for each of the seven sheriffs' offices for incoming reports by type and special condition referrals by type. The tables list the statewide percentage of child and special condition reports that the respective county received. The term "initial" refers to in-home and institutional investigations received on a child. The term "additional" references new allegations concerning a child that are received during a timeframe in which there is already an open and active initial investigation. "Special condition" referrals include:

- 1. child-on-child sexual abuse;
- 2. parent seeking assistance; and
- 3. child is without custodial care or supervision as the caregiver/parent is reported unavailable.

Broward Sheriff's Office

Broward Sheriff's Office received 11,516 child investigations and special condition referrals, which averaged 959.67 reports and special condition referrals monthly in FY 2019-2020. Special Condition referrals accounted for 8.38% of the intake workload. Broward County had a monthly average of 2.16 intake reports received per 1,000 children residing in the county. Note: The rate of reports excludes special condition referrals.

SECTION II: PEER REVIEW PROCESS AND FINDINGS

Section 39.3065 (3)(d), F.S., requires the sheriff's program performance evaluation to be conducted by a team of peer reviewers from the respective sheriffs' offices that perform child protective investigations and representatives from the department. The on-site peer record review was postponed to the spring of 2021 due to the pandemic and changes resulting from the DCF Accountability Act.

Sampling Methodology and Size

The peer review records review is conducted on a statistically significant sample of investigations closed during the previous year. The Life-of-Case monitoring instrument is new this year and was developed by the department's new Quality Office using requirements from the Federal Child and Family Services Review, Rapid Safety Feedback Reviews, the previous peer review tool, special reviews, and instruments from other states. This is one unified instrument that will be used for all ongoing reviews of Child Protective Investigations. The instrument was tested internally and with partners, including all sheriffs' offices that conduct child protective investigations.

Life of Case Reviews

The Life-of-Case review tool was designed in Qualtrics to allow for all case review information to be entered into an electronic format which captures the responses of the reviewer and identifies the reviewer's assessment for each question. The review tool contains a reference to each question, whether the item is part of federal requirements, Florida Statue, Administrative Code, and/or policy and procedure as applicable. The review tool also includes skip logic to omit practice-specific questions for the sheriffs' offices not required to adopt the child welfare safety practice model. Listed under the following titled categories are core components of questions within the Life-of-Case Review tool:

Background

- Basic Case Demographics
- o Type of Report
- Maltreatment reported
- Drug of Choice for Substance Misuse cases
- o Mental Health Concerns
- Maltreatment findings
- Safety Determination
- o Removal
- Plan of Safe Care Requirements
- o Family Made Arrangement Requirements
- Pre-commencement Assessment Teams

• Commencement

- o Reporter contacted
- Assessment of Prior Reports and Service History
- Assessment of criminal History

Investigative Activities

- Time sensitive actions were taken by the Child Protective Investigator based on information gathered during the course of the investigation
- Collateral contacts relevant to inform safety decisions
- Sufficient information was collected from collateral contacts to inform safety decisions
- Mandatory referrals were made to the Child Protection Team, Law Enforcement, and the State Attorney's Office as applicable and recommendations followed

- The CPI participated in collaborative staffing including timely discussions around case dynamics with subject matter experts (SME's) and utilized that information in case decision(s) as appropriate
- o If open to Case Management, the case manager and Children's Legal Services (if judicial) were notified timely
- The case record, in its entirety, supports a thorough investigation with information that supports the final safety decision.
- o If not yet complete, the investigation is on track
- Maltreatment findings appropriately identified and supported within the totality of the investigation
- o Maltreatments added if new information obtained
- Risk Assessment completed accurately based on the totality of the information in the investigation identifying the correct risk level
- o Appropriate actions were taken based on the correct risk level
- O Child Protective Investigator attempted to link families with appropriate services if children determined to be safe; however, at high or very high risk

Interviews

- Qualitative and timely interviews conducted with Children
- Qualitative interviews conducted with Parents/Caregivers/Adults

Assessment of Present Danger

- o Completion of the Present Danger Assessment background history on participants
- Supporting documentation for identified threat or absence of present danger
- Subsequent Present Danger Assessments

• Safety Planning - Present Danger

- o Present Danger Safety Plan actively monitored by Child Protective Investigator
- o Supervisor conducted thorough and timely review of the Present Danger Safety Plan
- o Background Screenings conducted for all informal safety service providers

Impending Danger - Family Functioning Assessment and Safety Planning

- Accurate Assessment of Impending Danger
- o Impending Danger safety plan sufficient to control identified danger threats
- Impending Danger safety plan actively monitored by the Child Protective Investigator

Removal

- Prior to a removal, Child Protective Investigator made concerted efforts to provide services to prevent the removal through safety planning in the least intrusive means achievable to ensure child safety
- Concerted efforts made to place siblings together
- Concerted efforts made to place children with relatives

Supervision

- Supervisor provided guidance at pre-commencement if required
- o Supervisor provided appropriate and timely guidance at initial consultation
- Supervisor provided appropriate guidance around critical junctures
- Supervisor ensured follow-up actions were completed

- The Supervisor reviewed the overall safety determination (in the form of a final closure summary documenting support of the final safety decision)
- o 2nd Tier completed as required

The rating of file reviews uses a yes/no/not applicable approach. Additional functionality was built into the instrument to allow for deeper analysis for any No ratings to help drive improvement activities.

The review process allows for results to be tabulated for the assessment on the above areas and immediate feedback provided at the end of the evaluation via a prepared report for the sheriff's office under review. The web-based tool will allow peer reviewers to complete an onsite stratification of the data at the conclusion of the review. In addition, it allows for deeper analysis into the data to identify specific areas of concern by pinpointing a question and then identifying the unit, supervisor, or child protective investigator assigned. This enables the program administrator to directly act toward correcting any area of deficiency and identifying best practices within any unit, supervisor, or investigator.

SECTION III: OUTCOME MEASURE ATTAINMENT

Section 39.3065(3)(b), F.S., requires sheriffs' offices to operate in accordance with performance standards and outcome measures established by the Florida Legislature. Child protection and child welfare outcomes are established in section 409.986(2), F.S. The General Appropriations Act sets forth appropriations allocated through multi-year grant agreements with the seven sheriffs' offices performing child protective investigations. The current grant agreements cite two performance measures for the sheriffs' offices. Users enter the data for these performance measures and others into Florida's statewide automated child welfare information system, FSFN. This system produces management reports used for determining statewide performance and outcomes.

The FSFN management report, "Leader Board for Investigations," provides the data for the two performance measures included in the sheriffs' grant agreements. The FSFN report lists performance for each department region and sheriff's office that operates a child protective investigation program. The report period represents FY 2010-2020. The algorithms for calculating the outcome measures are established by the department. The algorithms are as follows:

- Investigations commenced within 24 hours: The numerator is the number of reports commenced within 24 hours of receipt of the report. The denominator is the total number of reports closed in the report period.
- Victims seen within 24 hours of report received: The denominator is the number of victims listed in recorded reports. The numerator is the total number of victims seen within 24 hours as recorded in the FSFN computer system.

Performance Measure 1: Percent of investigations commenced within 24 hours [Target Goal – 99.5%]

FSFN captures this performance measure on reports coded in-home and institutional. The special condition referrals and reports closed as "duplicate" or "no-jurisdiction" are not applicable to this measure. Florida Administrative Code (F.A.C.) references this performance measure as does section 39.201(5), F.S., which states, in part, "If it appears that immediate safety or well-being of a child is endangered, that the family may flee, or the child will be unavailable for purposes of conducting a child protective investigation, or that the facts otherwise so warrant, the department shall commence an investigation immediately, regardless of the time of day or night. In all other child abuse, abandonment, or neglect cases, a child protective investigation shall be commenced within 24 hours after receipt of the report."

Commencement of Investigations within 24 Hours


In FY 2019-2020, there was a total of 183,259 initial and additional reports as well as special condition referrals statewide. Of this number, 148,808 (81.20%) were regular initial abuse reports; 20,471 (11.17%) were special condition referrals, and 13,980 (7.63%) were additional reports. All of these required an initial 24-hour or immediate response with the following exceptions:

- 1. "Parent Needs Assistance" referrals may be handled outside of the customary 24-hour, face-to-face commencement response, as permitted by department protocol.
- 2. "Foster Care Referrals" (FCR) may be commenced within 48 hours if initial circumstances warrant, as permitted by department protocol.

Calls received by the Florida Abuse Hotline with supplemental information (with no new/additional victims, alleged perpetrators, or allegations of harm on open investigations) were not referenced or added to the total number of reports received, since supplemental reports do not require an additional commencement or face-to-face visit by the child protective investigator. There were 24,588 supplemental reports added to open investigations in FY 2019-2020, averaging 2,049 supplemental reports accepted monthly.

FSFN performance reports exclude special condition referrals from being included in the data tracking on this measure. Therefore, this data would exclude child-on-child sexual abuse referrals, foster care referrals, parent unavailable referrals, and parent needs assistance referrals. The data provided also excludes those report commencements that are associated with an additional report and investigations closed as being a duplicate or as no-jurisdiction.

FSFN data includes only initial commencements. This data is based on those initial reports that closed each month. If the data reflected a commencement within 24 hours of report acceptance, the commencement would be within compliance.





FSFN captures this performance measure on reports coded in-home and institutional. The special condition referrals and reports closed as "duplicate" or "no-jurisdiction" are not applicable to this measure. The performance measure is based on 65C-29.003(1)(b), F.A.C. which states, "Commencement of the investigation is the first attempt to complete an on-site visit for the purpose of making a face-to-face contact with the child victim of the report within twenty-four hours of acceptance of the report..."

Section 39.302(1), F.S., references this performance measure. The subsection states, in part: "...the department shall initiate a child protective investigation within the timeframe established under s. 39.201(5) ..."

Victims Seen Within 24 Hours

Sheriffs' grant agreements include the performance measure of 85% of child victims being seen within 24 hours of the receipt of a report. FSFN captures this performance measure on reports coded in-home and institutional. The special condition referrals and reports closed as "duplicate" or "no-jurisdiction" are not applicable to this measure. The Sheriffs' Offices collectively performed at 92.13%, DCF at 93.03%, with a statewide performance of 92.8%. The DCF internal target for this item is 90%.

Additional Department Program Performance Measures


Other Leader Board Outcome Performance Measures, although not in the sheriffs' grant agreements, are important to overall casework practice statewide. Overall, in these additional Leader Board measures, the sheriffs' office averages exceeded the statewide averages.

Closure of the Investigation by the 60th Day

FSFN captures this performance measure on reports coded in-home and institutional. Special condition referrals, duplicate, and no-jurisdiction reports are not applicable to this measure. The basis for this performance measure is section 39.301(16), F.S., which states, "The department shall complete its protective investigation within 60 days after receiving the initial report, unless:

- (a) There is also an active, concurrent Criminal investigation that is continuing beyond the 60-day period and the closure of the protective investigation may compromise successful criminal prosecution of the child abuse or neglect case, in which case the closure date shall coincide with the closure date of the Criminal investigation and any resulting legal action.
- (b) In child death cases, the final report of the medical examiner is necessary for the department to close its investigation and the report has not been received within the 60-day period, in which case the report closure date shall be extended to accommodate the report.
- (c) A child who is necessary to an investigation has been declared missing by the department, a law enforcement agency, or a court, in which case the 60-day period shall be extended until the child has been located or until sufficient information exists to close the investigation despite the unknown location of the child."



During fiscal year 2019-2020, the Sheriffs' Offices collectively performed at 97.86%, DCF at 98.02%, with a statewide performance of 97.89%.

SECTION IV: COST EFFICIENCY

This section provides an assessment of the cost efficiency based on the cost for initial and additional reports for the sheriffs' offices and department regions. The table below provides expenditures and costs per report received during FY 2018-2019 and FY 2019-2020. Dividing actual expenditures by the number of reports received determines the cost per report, not using averages.

The cost for sheriffs' offices ranged from a low of \$951 for Walton to a high of \$1,687 for Pinellas with an overall average cost of report for sheriffs of \$1,420. The cost for the department ranged from a low of \$1,198 in the Suncoast Region to a high of \$1,473 in the Southern Region with an overall average cost of \$1,336 per investigation. The overall difference in cost between the sheriffs' offices and the department was \$84 per report.

The cost per investigation increased by 18.045% for the sheriffs' offices and 16.38% for the department. The overall statewide cost per investigation increased 16.78%. The overall number of investigations decreased 14.85% for the sheriffs' offices and 13.55% for the department. It should be noted that reports to the abuse hotline were reduced during the pandemic.
