Family First Prevention Services Act (FFPSA) Group Home Provider Survey Results

APRIL 2019

PURPOSE

The survey, conducted by the Office of Child Welfare, was intended to obtain input from DCF licensed group home providers regarding the department's current utilization of residential care service. The information and recommendations gathered from this survey will assist in the department's planning and implementation of the Family First Prevention Services Act (FFPSA) provisions related to residential care settings.

There were a total of 148 provider responses received, with a total of 199 active licenses. A single response may include feedback from providers who are located in more than one region with more than one home. Data provided is solely based on those providers who participated in the survey.

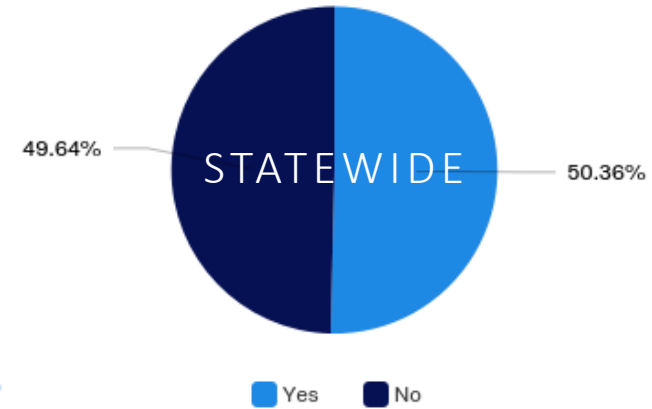
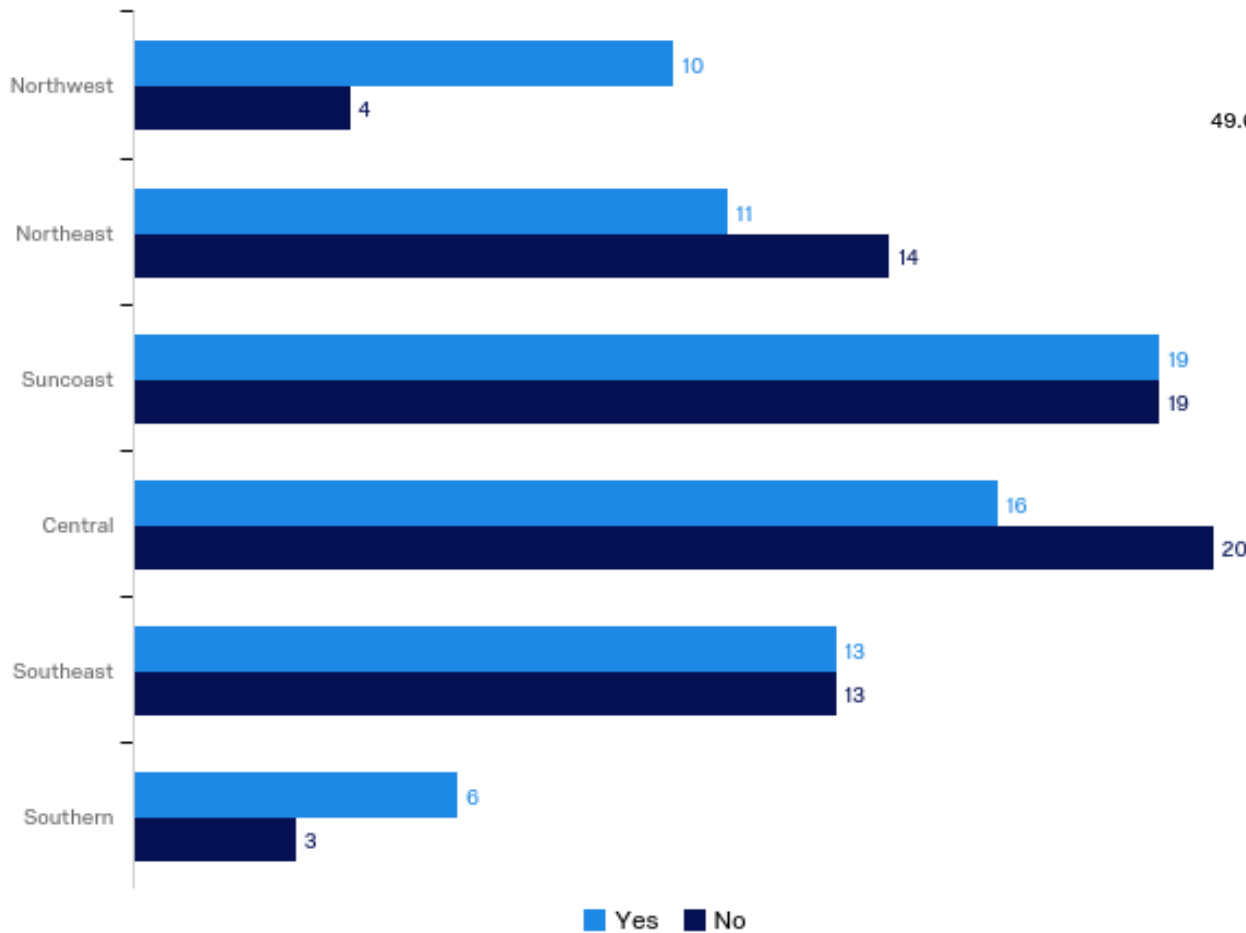
STATEWIDE LICENSED GROUP CARE SETTING TYPE PER REGION

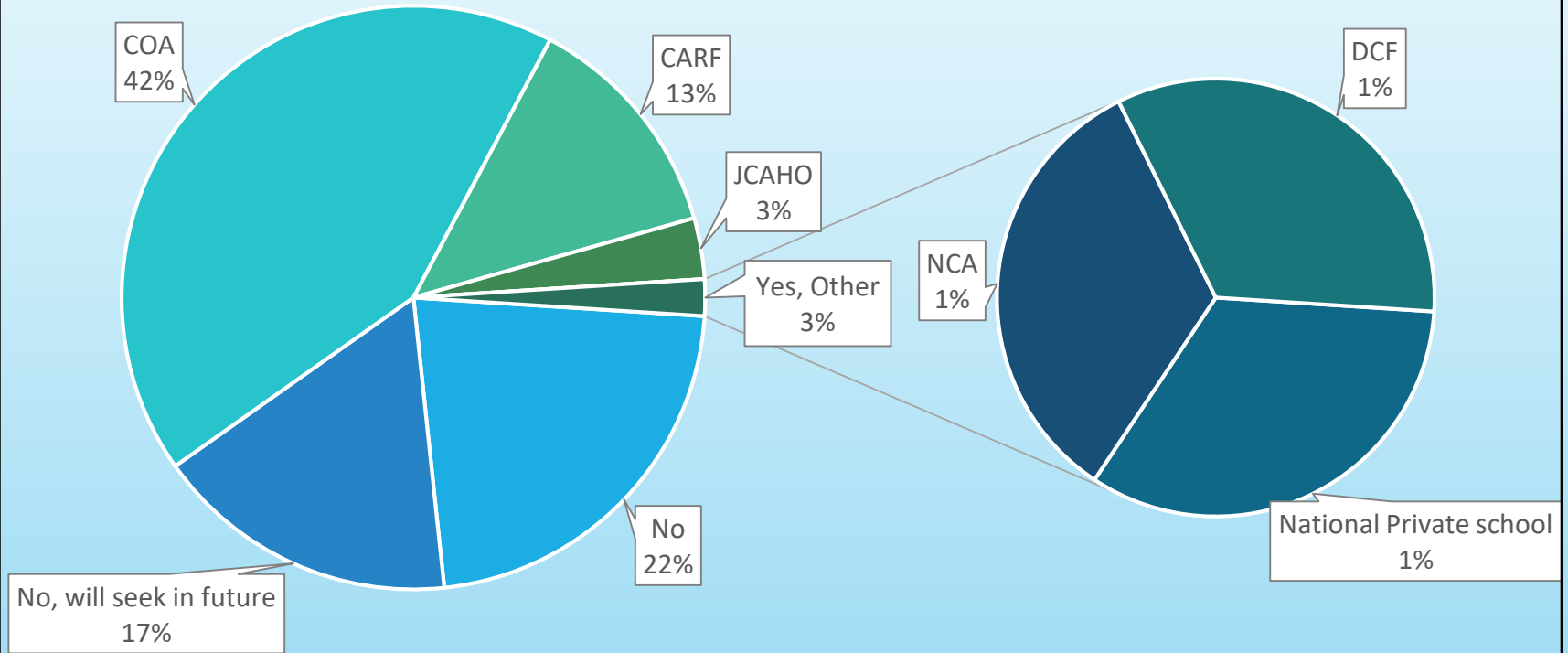

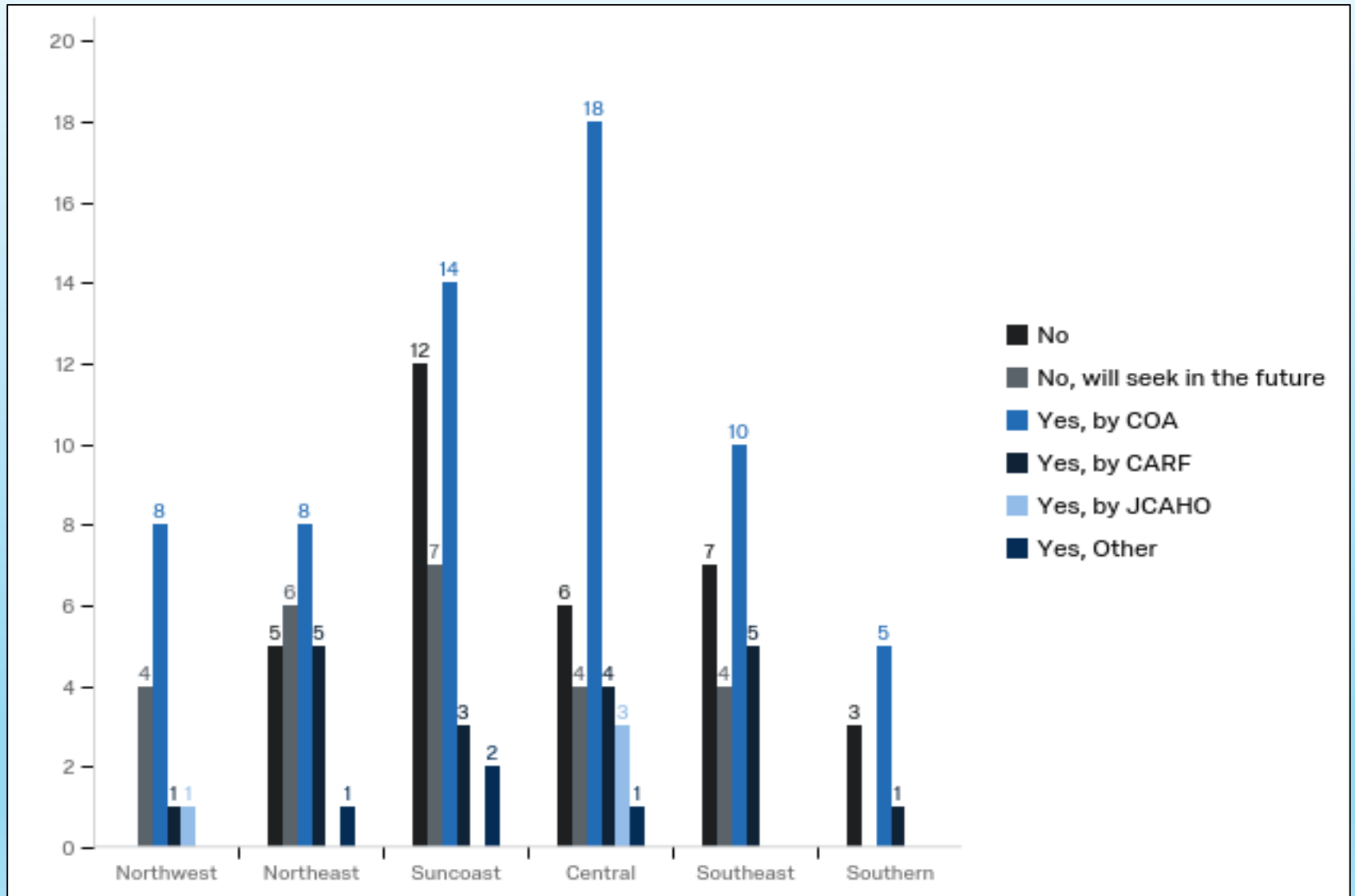

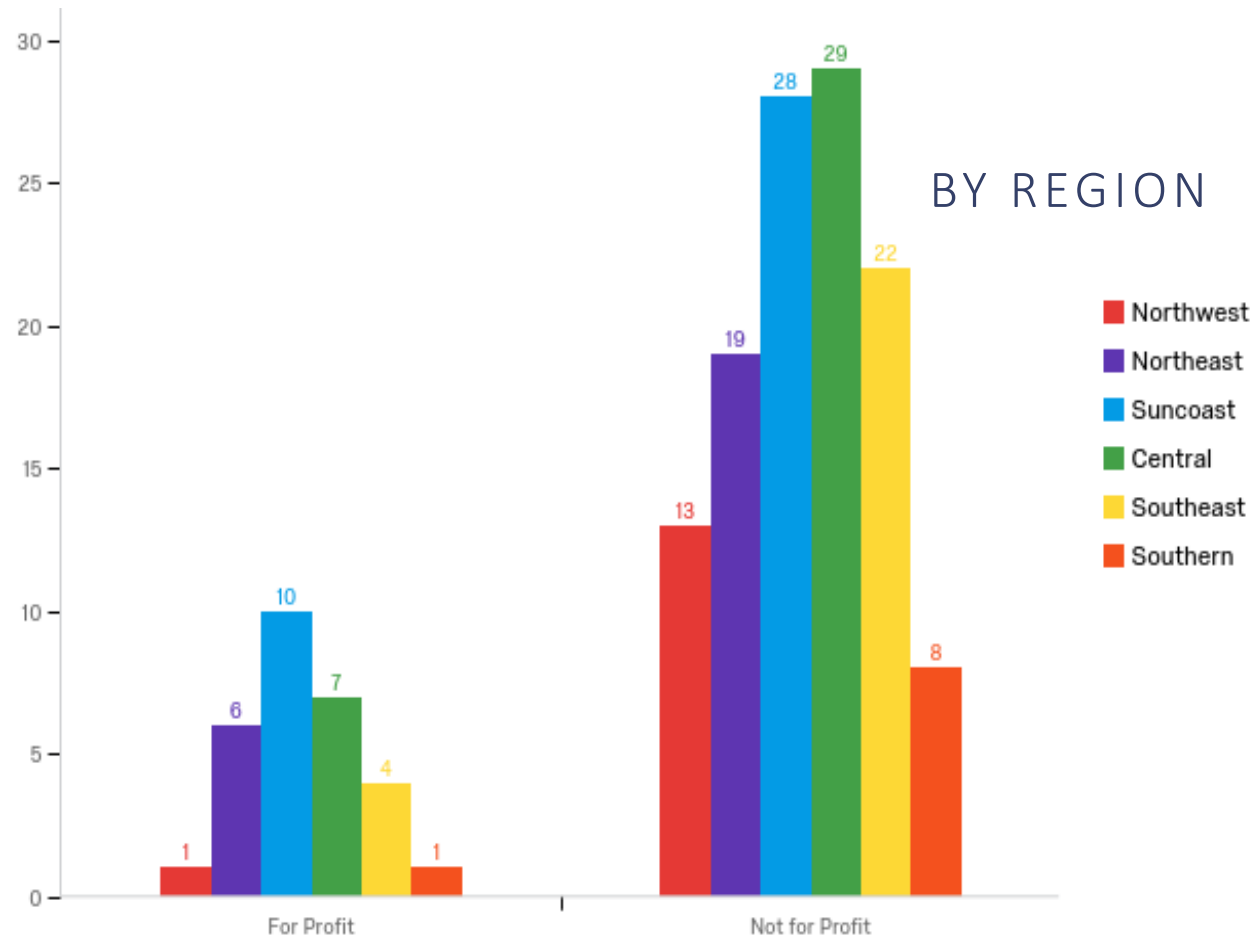
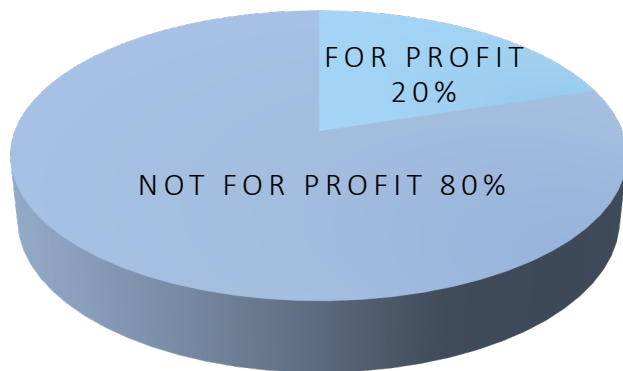
PROVIDER ACCREDITATION BY REGION

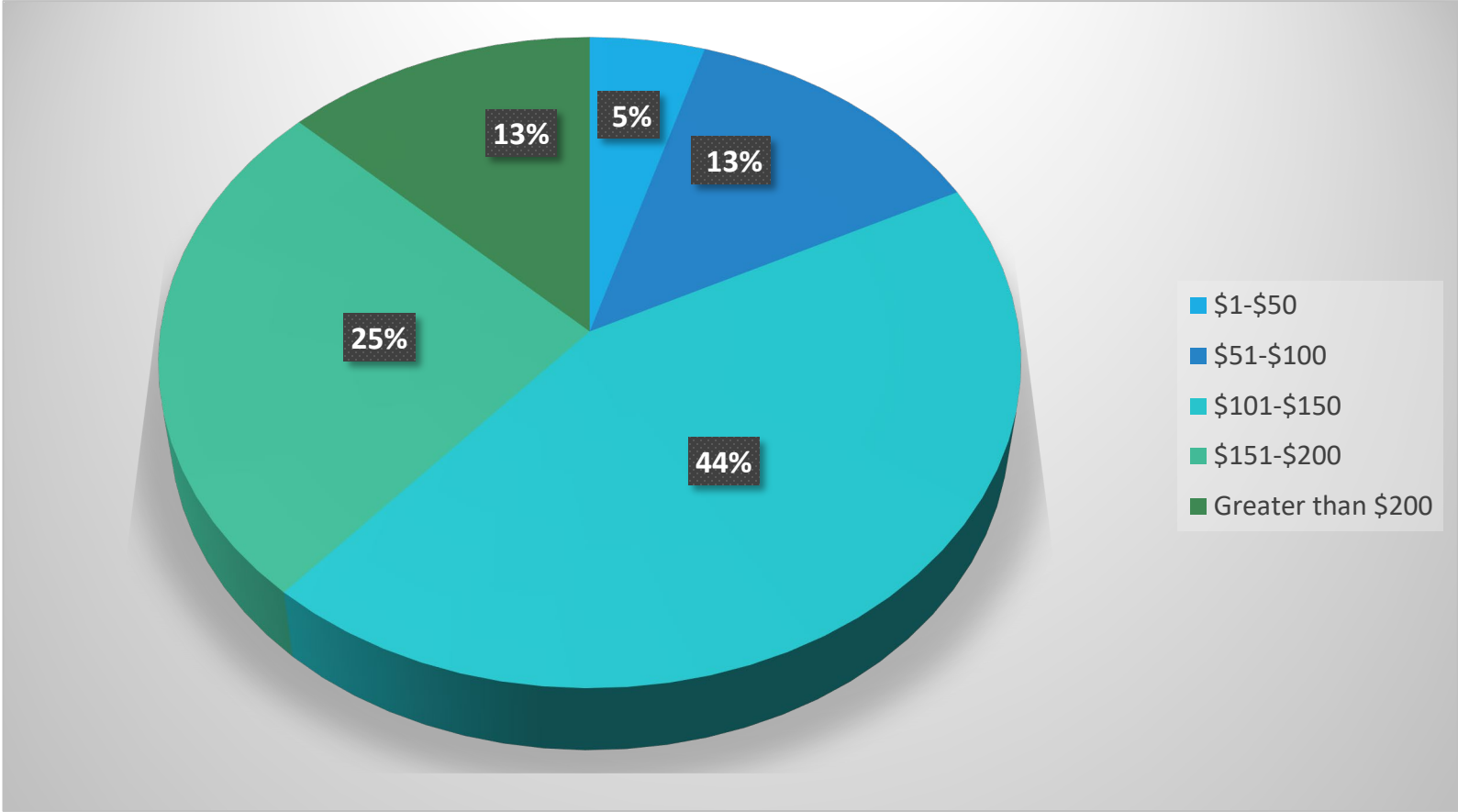

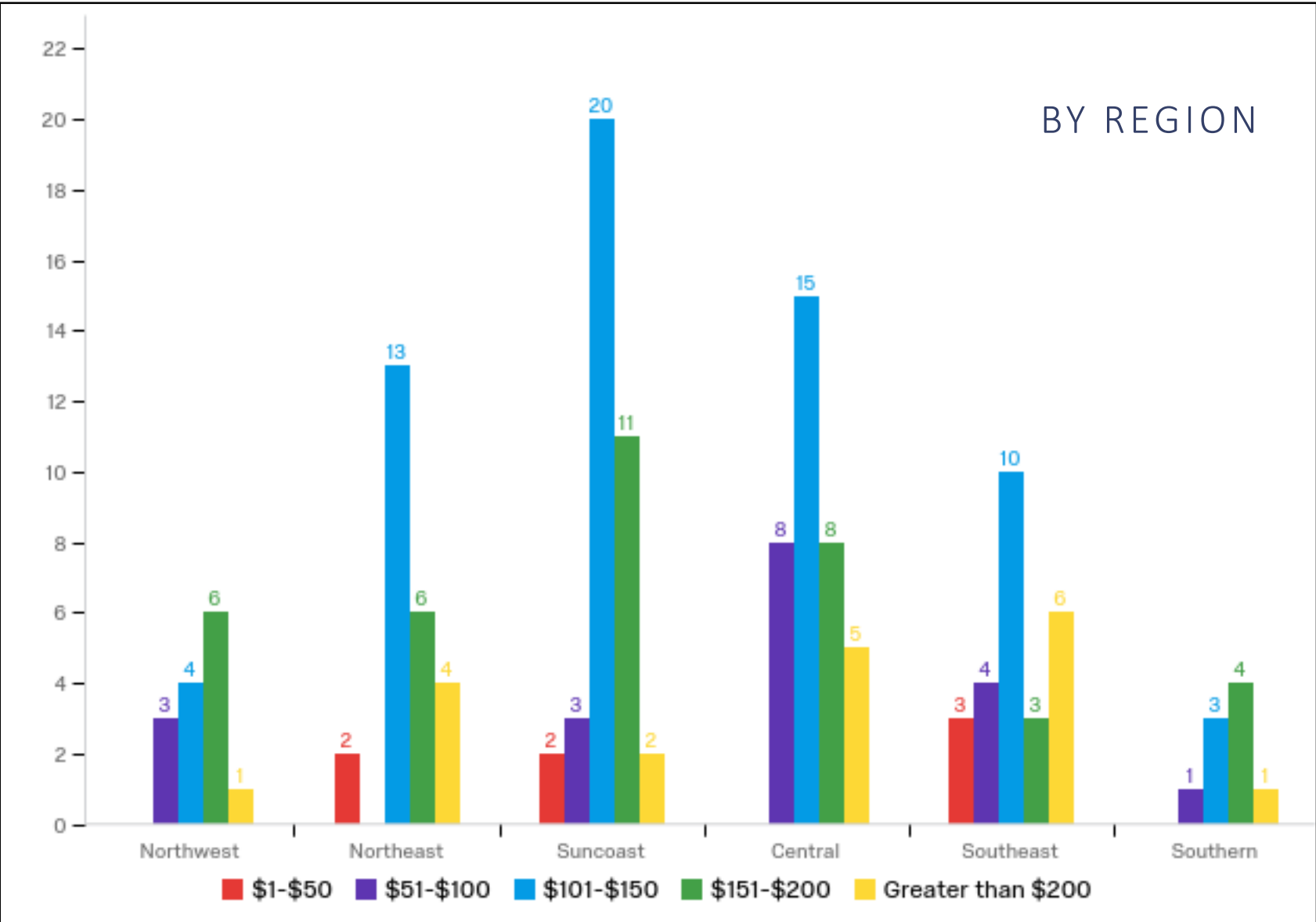


STATEWIDE AVERAGE PROVIDER ROOM AND BOARD RATES

The term “foster care maintenance payments” also known as room and board means payments to cover the cost of (and the cost of providing) food, clothing, shelter, daily supervision, school supplies, a child’s personal incidentals, liability insurance with respect to a child, reasonable travel to the child’s home for visitation, and reasonable travel for the child to remain in the school in which the child is enrolled at the time of placement. In the case of institutional care, such term shall include the reasonable costs of administration and operation of such institution as are necessarily required to provide the items described in the preceding sentence. *RATES ARE PER DAY/PER CHILD



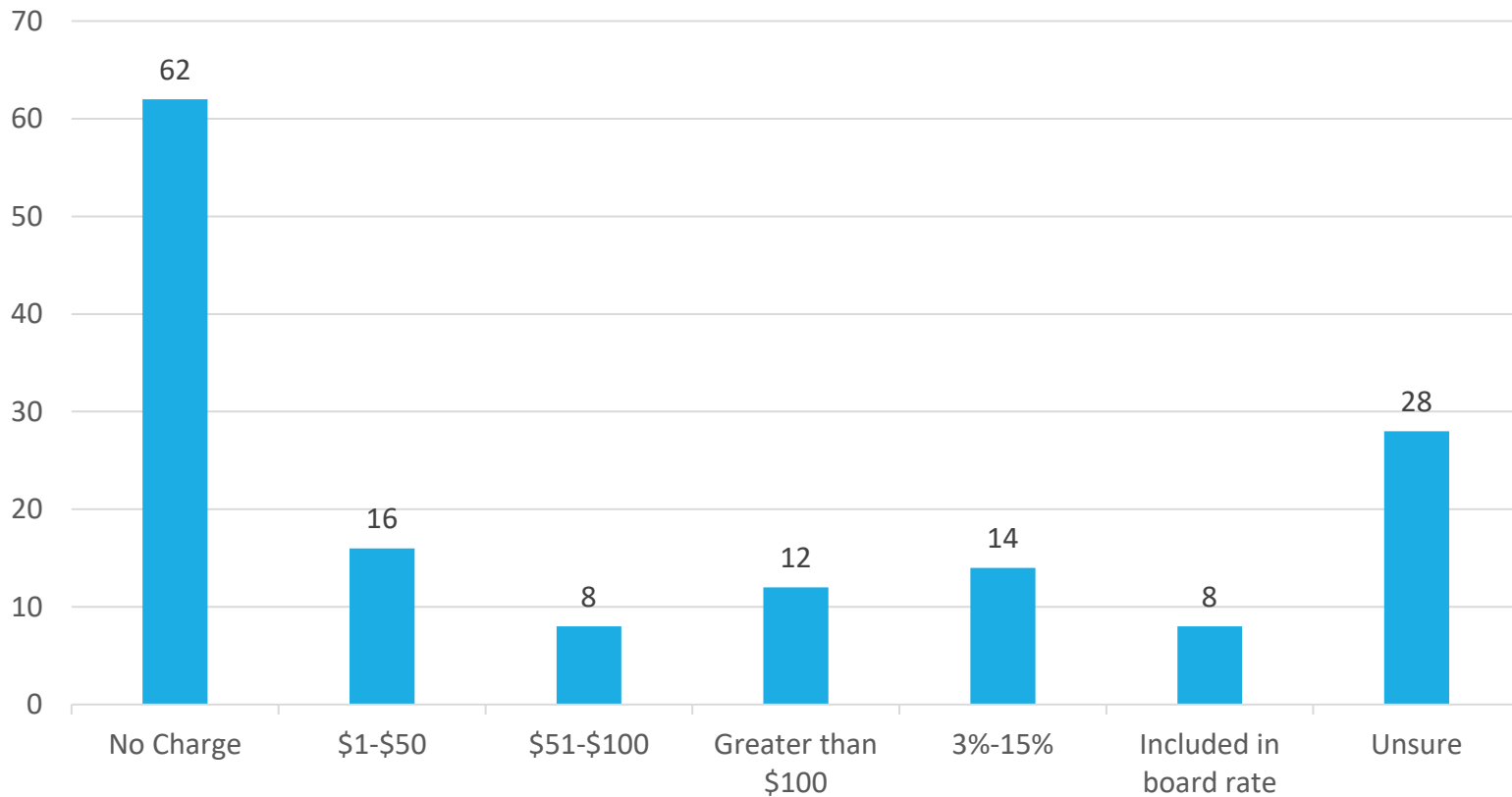

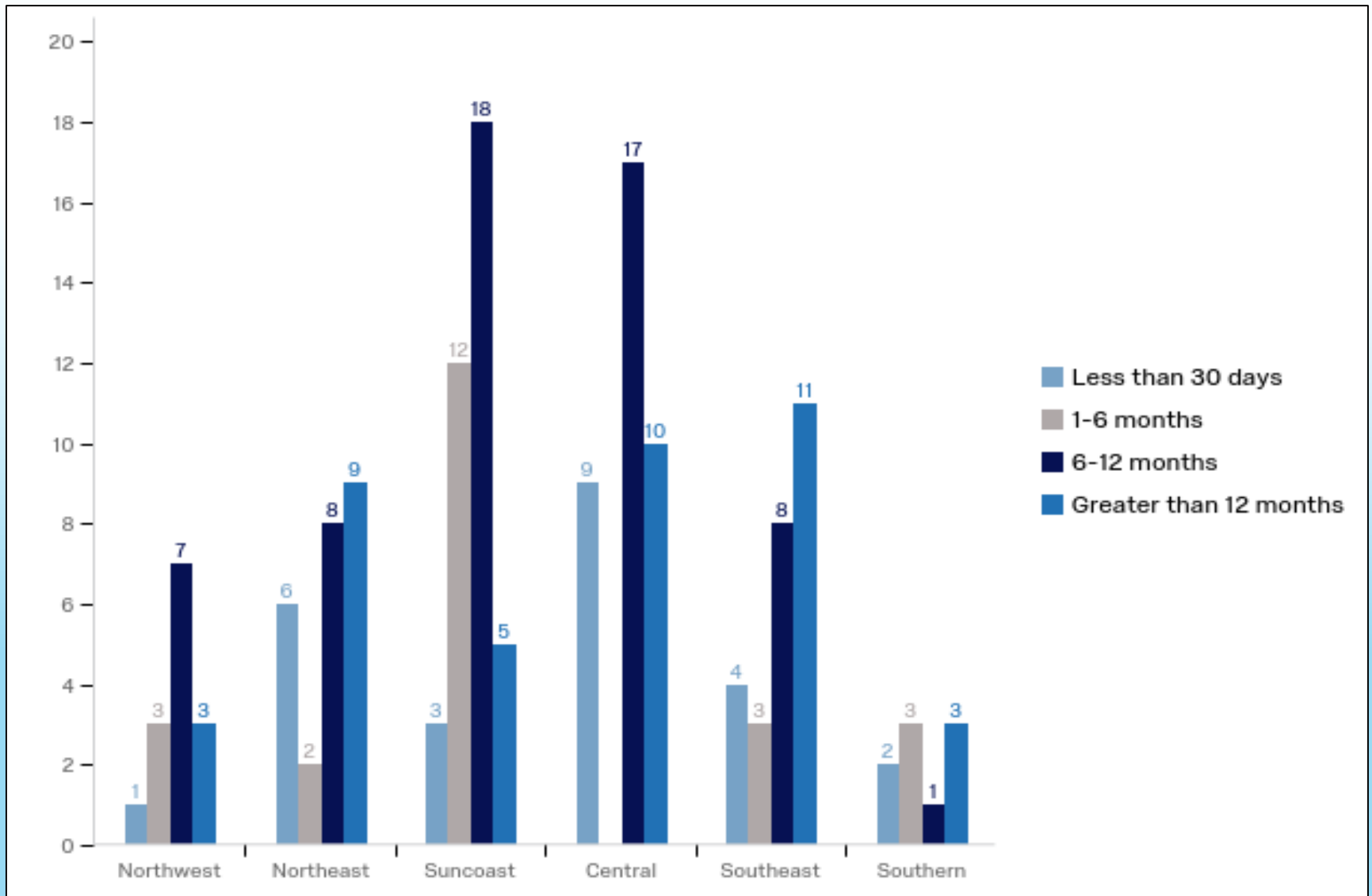
AVERAGE PROVIDER ROOM AND BOARD RATES

AVERAGE PROVIDER ADMINISTRATION RATES

The following are examples of allowable administrative costs necessary for the administration of the foster care program: (i) Referral to services; (ii) Preparation for and participation in judicial determinations; (iii) Placement of the child; (iv) Development of the case plan; (v) Case reviews; (vi) Case management and supervision; (vii) Recruitment and licensing of foster homes and institutions; (viii) Rate setting; and (ix) A proportionate share of related agency overhead. (x) Costs related to data collection and reporting. Allowable administrative costs do not include the costs of social services provided to the child, the child's family or foster family which provide counseling or treatment to ameliorate or remedy personal problems, behaviors or home conditions. *RATES ARE PER DAY/PER CHILD

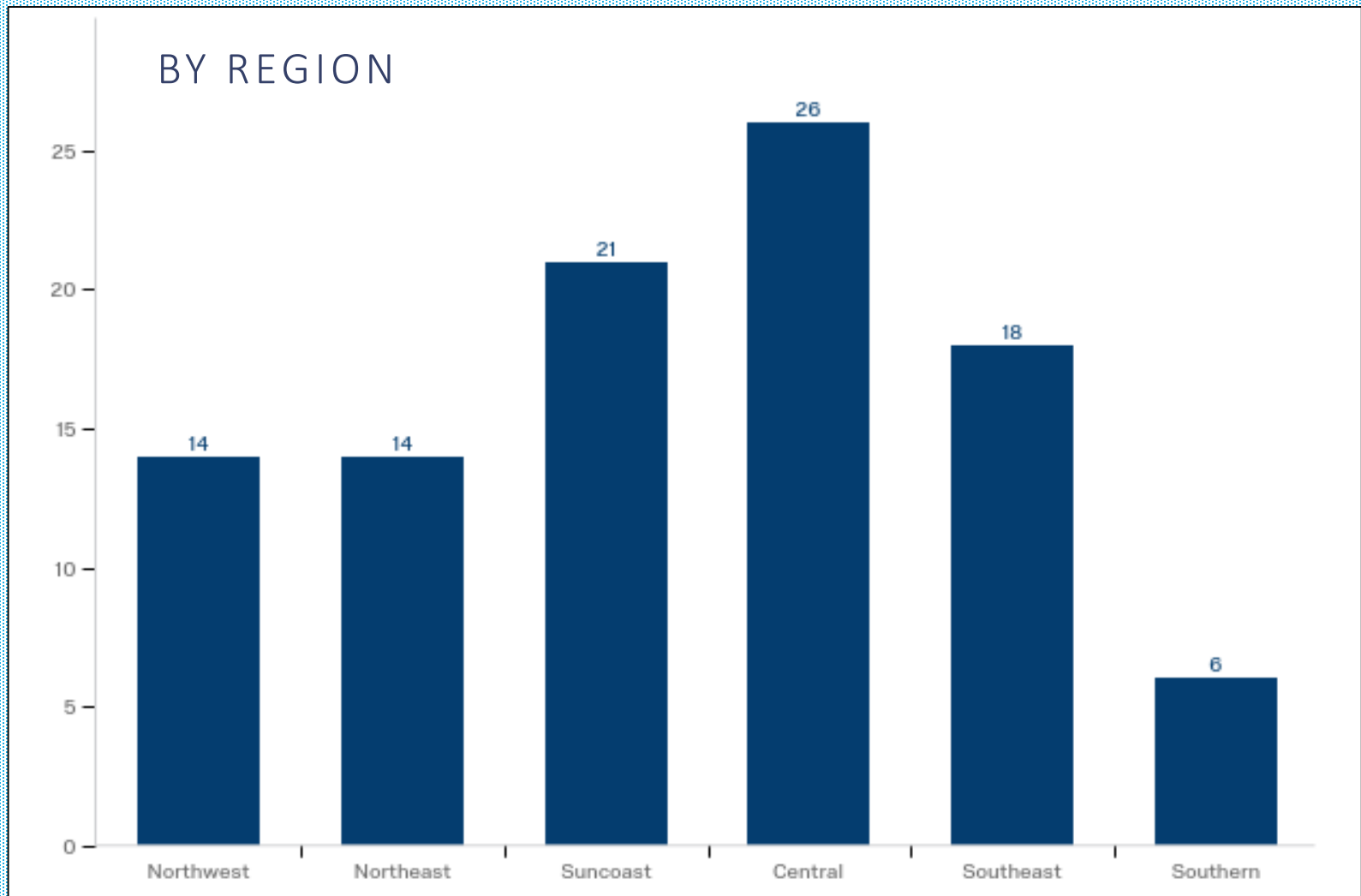

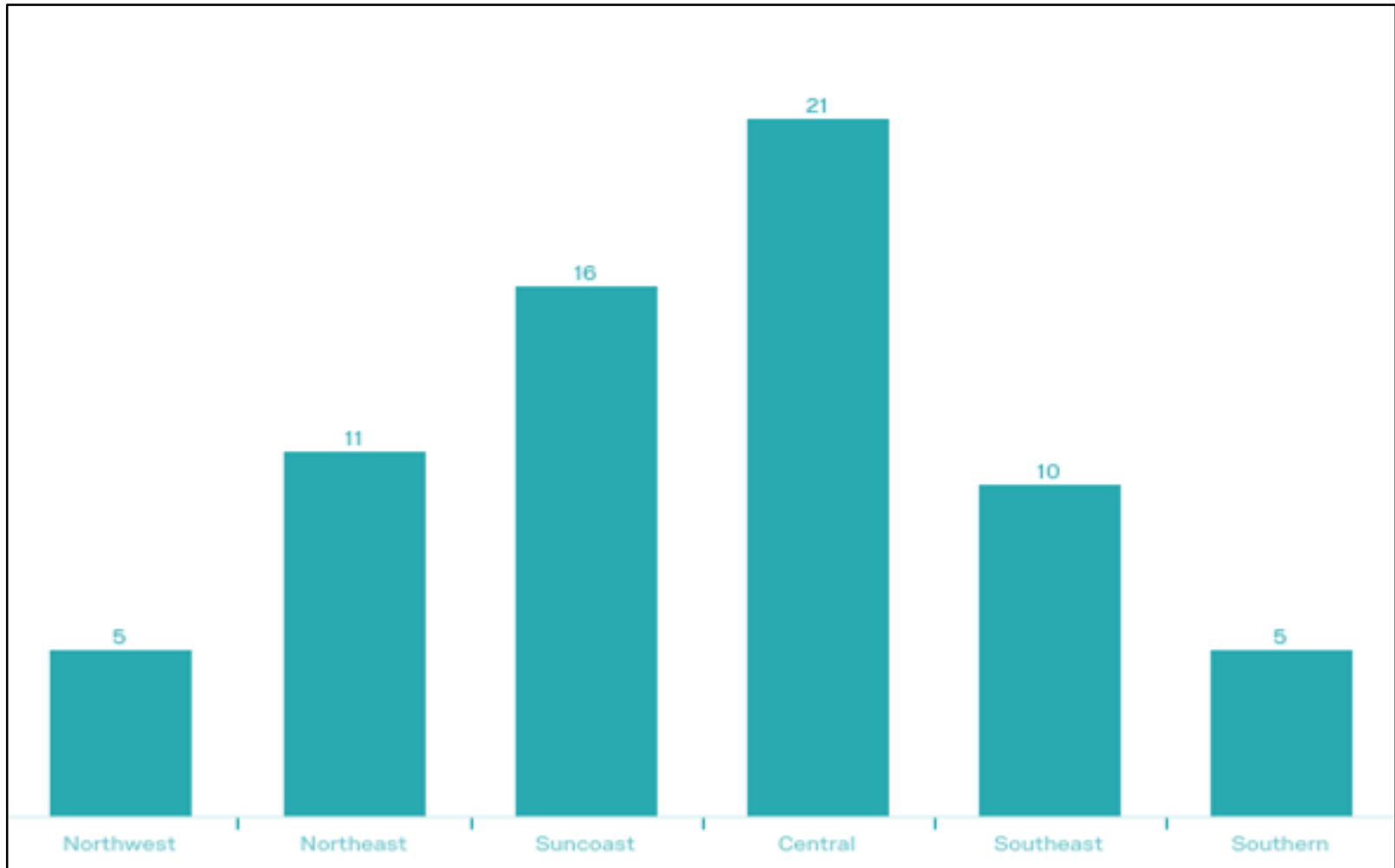

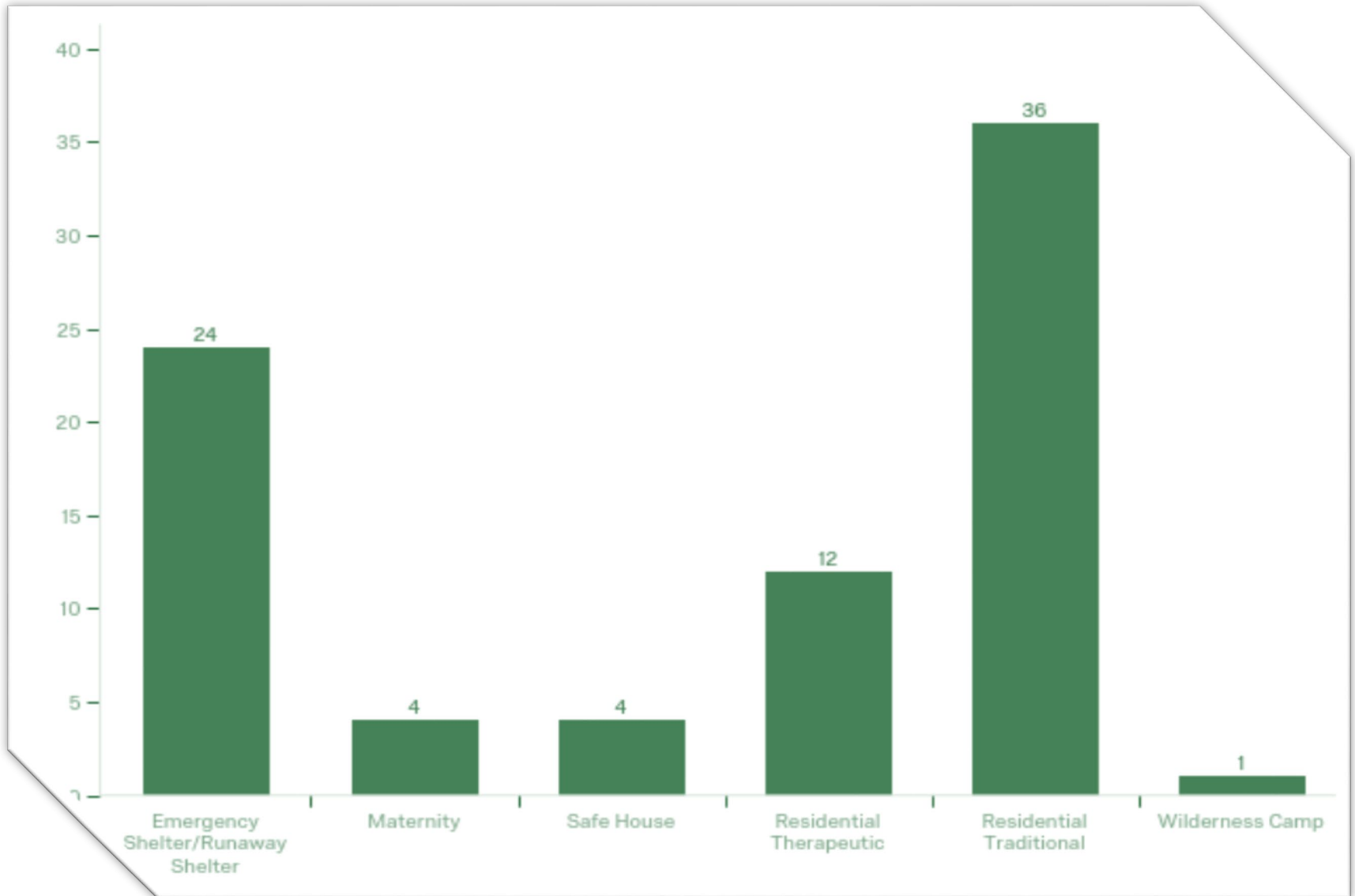
NUMBER OF PROVIDERS WHO UTILIZE A TRAUMA INFORMED TREATMENT MODEL

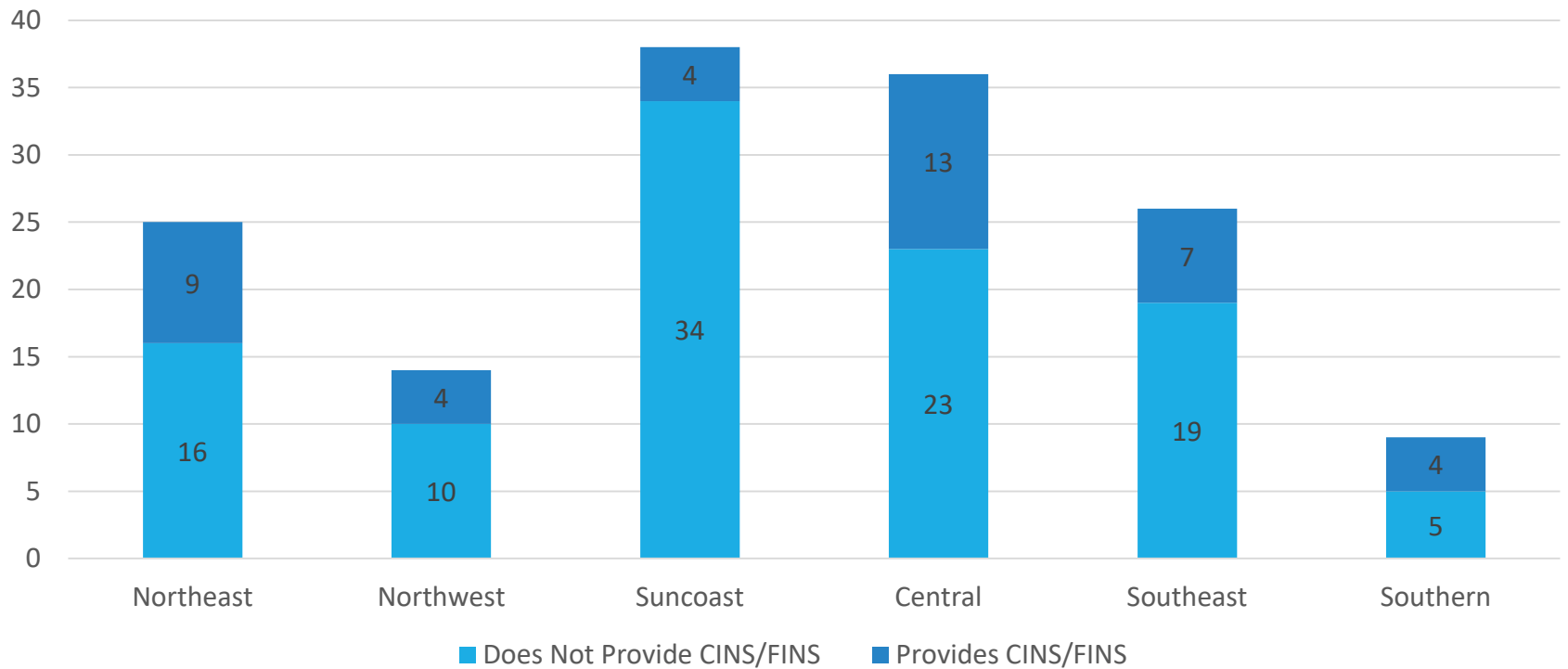


NUMBER OF PROVIDERS BY REGION WITH LICENSED CLINICAL/NURSING STAFF



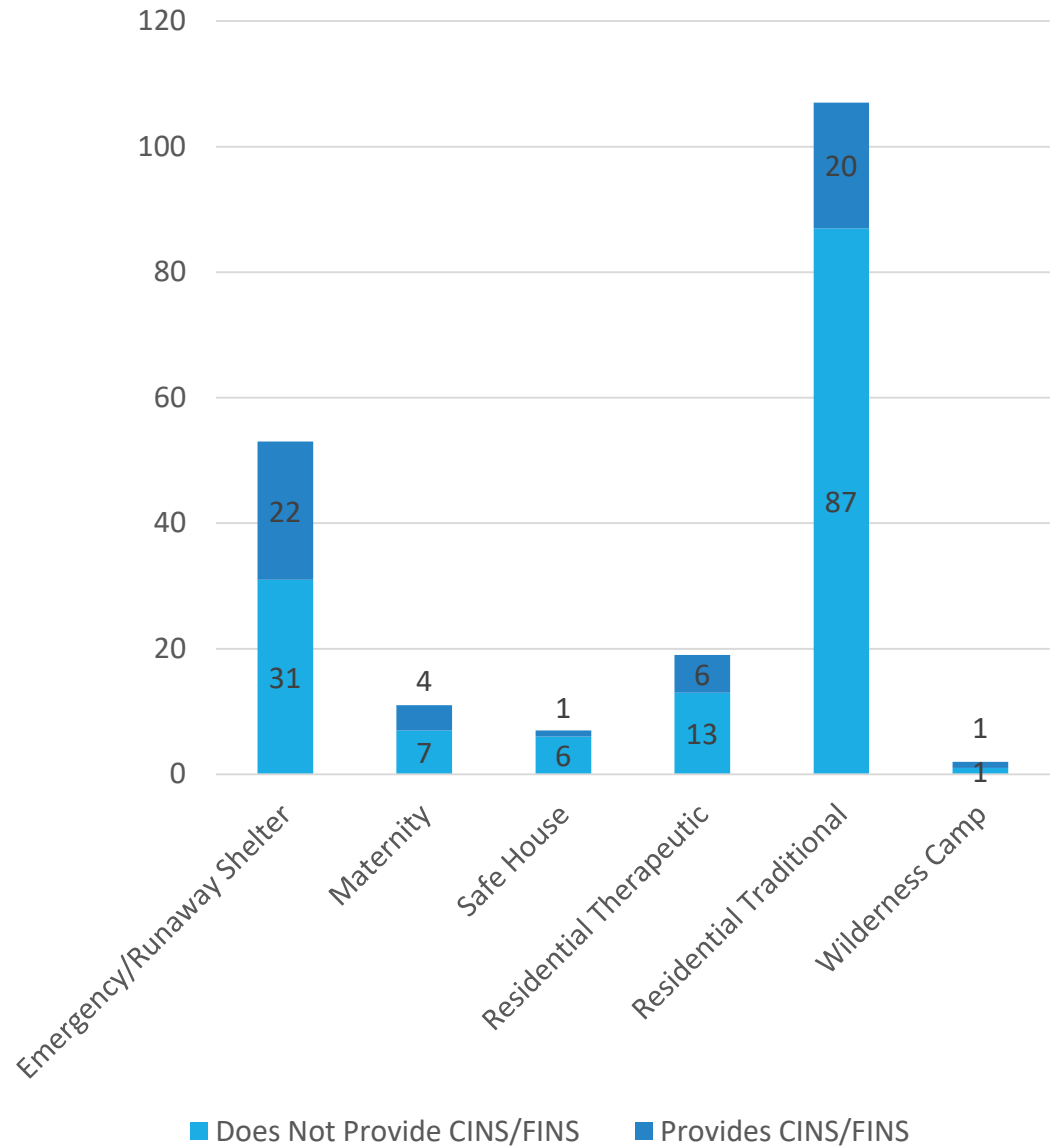
STATEWIDE GROUP HOME SETTINGS WITH LICENSED CLINICAL/NURSING STAFF

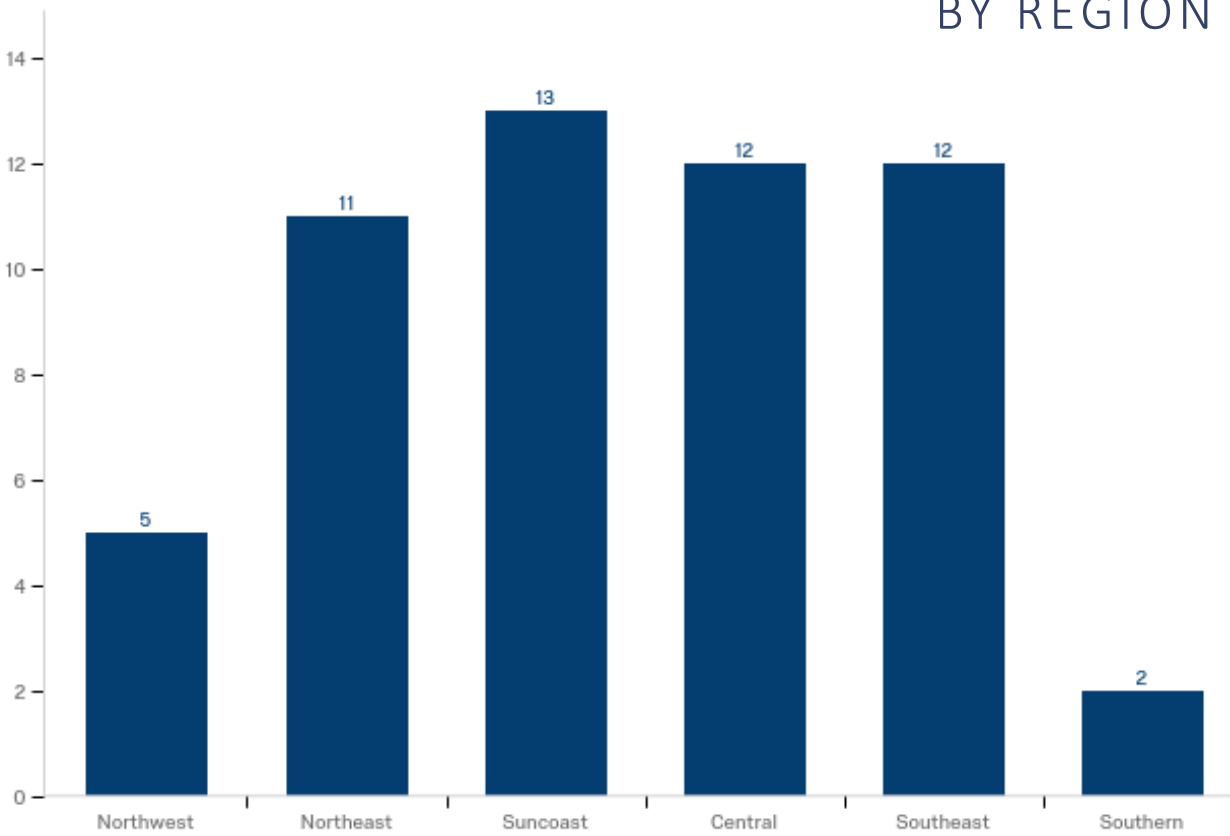

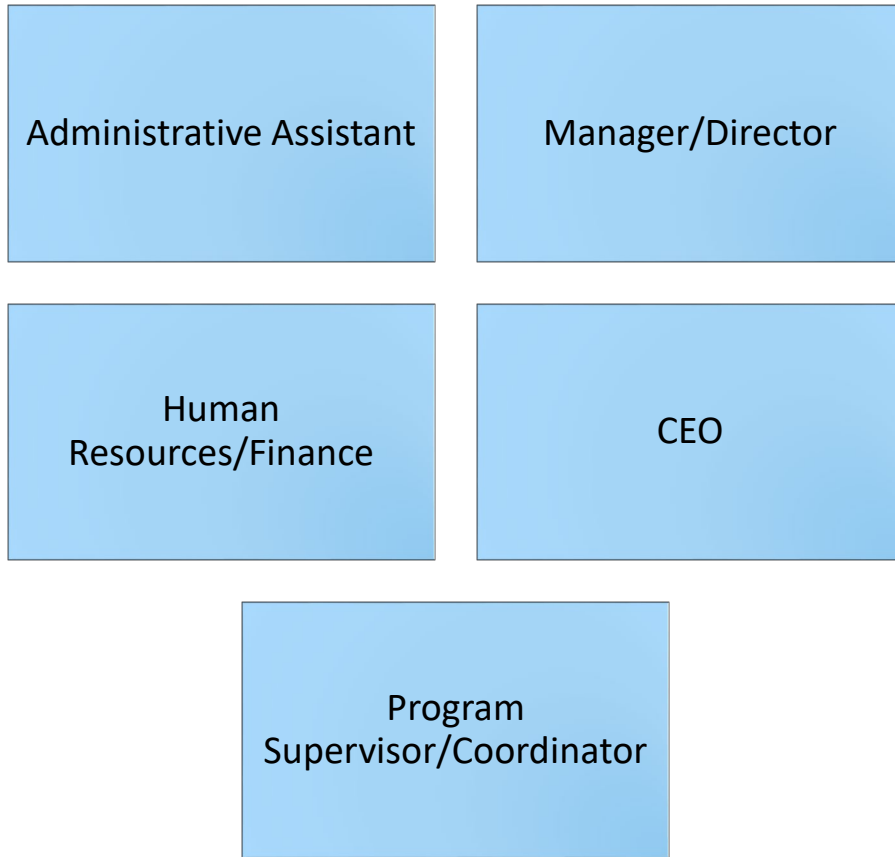

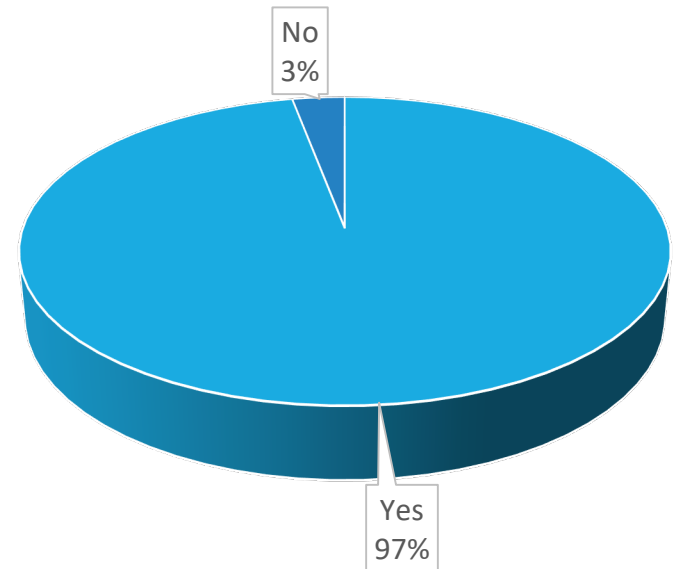
PROVIDERS WITH DESIGNATED STAFF CONDUCTING BACKGROUND SCREENINGS FOR EMPLOYEES



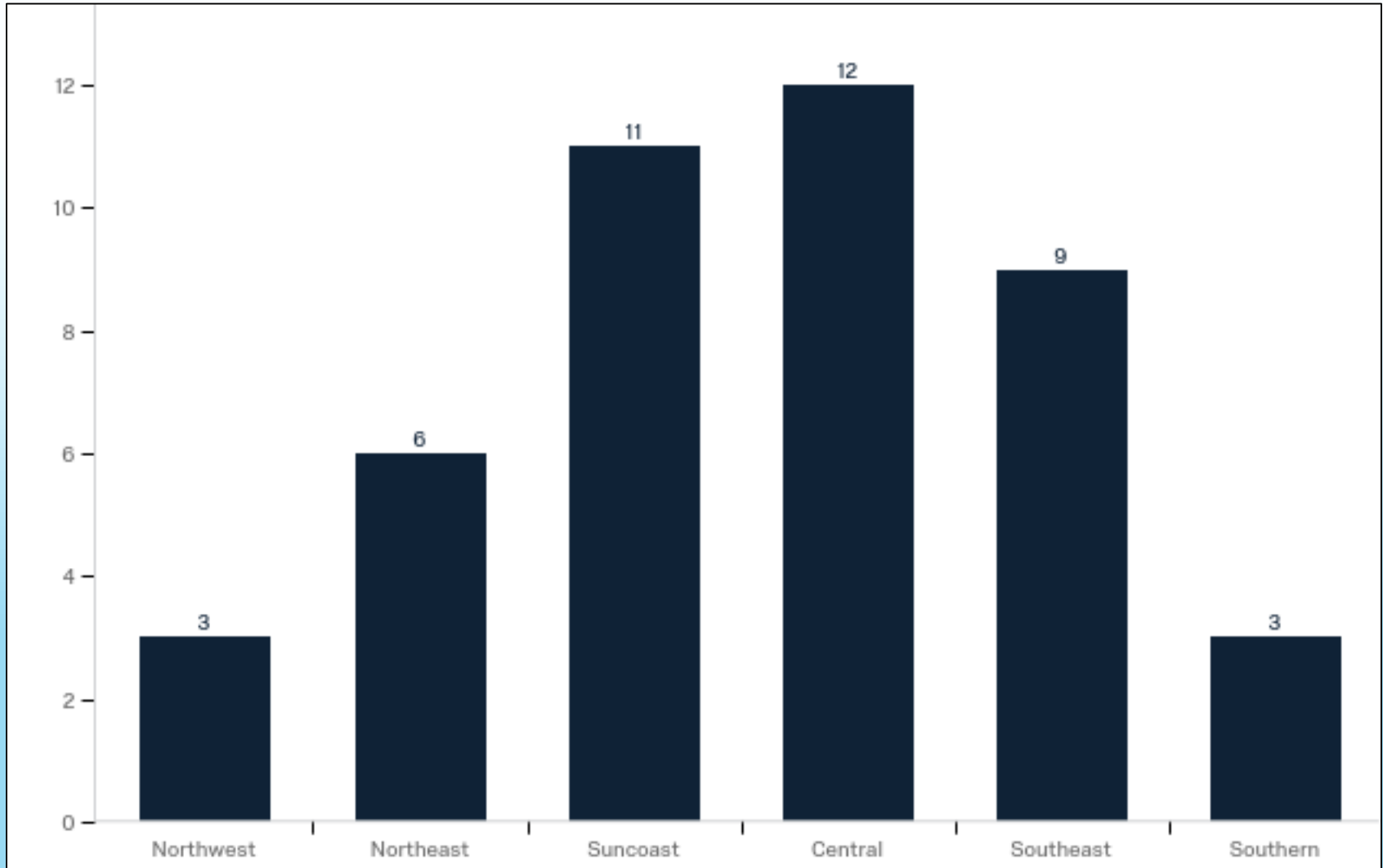

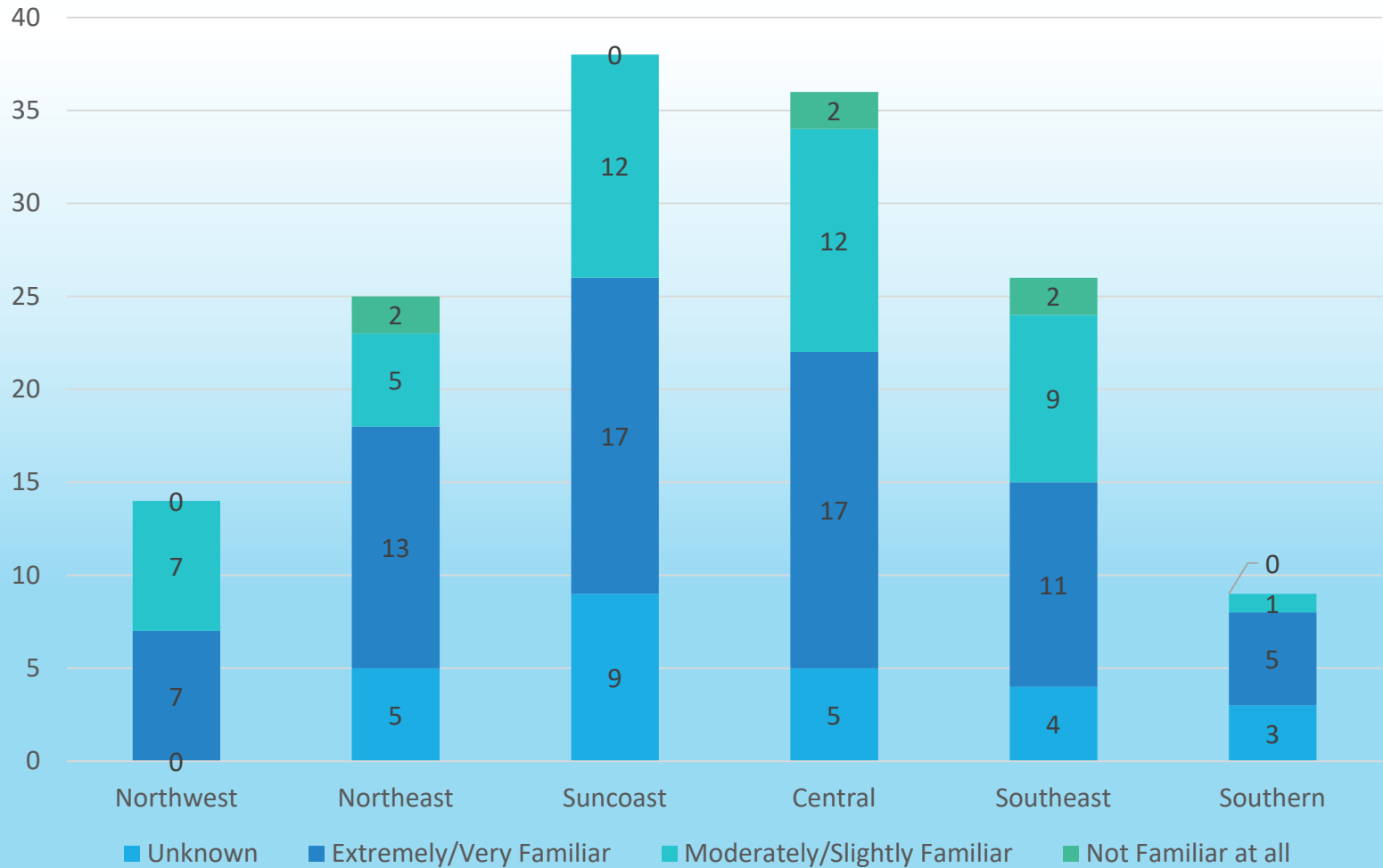

NUMBER OF PROVIDERS WHO UTILIZE THE HOUSE PARENT MODEL PER REGION

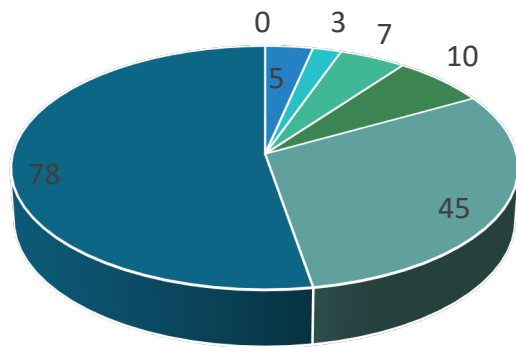


PROVIDER FAMILIARITY WITH FFPSA CHANGES



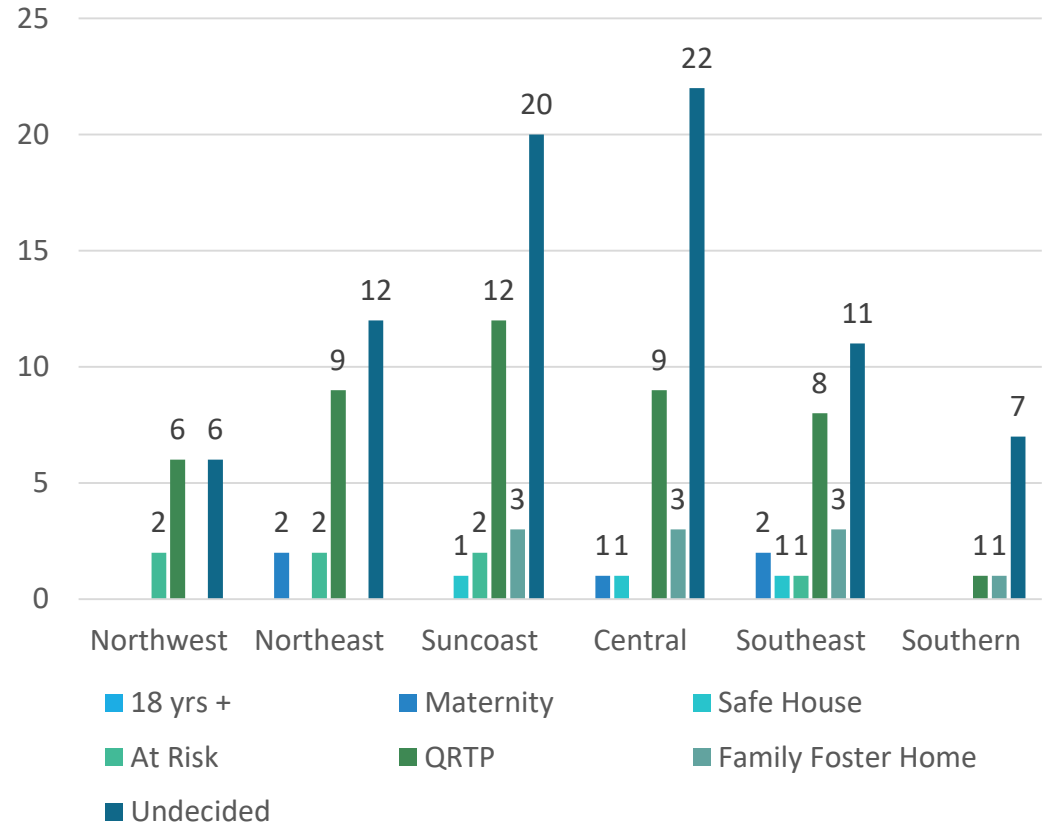
