SUBJECT: Announcement – Child Welfare Public Facing Dashboards are now live

INFORMATIONAL MEMO

PURPOSE: The purpose of this memorandum is to inform all stakeholders that the Public Facing Results Oriented Accountability Interactive Child Welfare Dashboards are now available on the DCF Internet:

BACKGROUND: These dashboards will provide all Child Welfare stakeholders in Florida, including the public -- access to an interactive dashboard experience utilizing Tableau visualization software. The Child Welfare Dashboards include a home page that offers child welfare statistics at a glance where users can then interface deeper into current and historical data on topics that include allegations accepted by the Florida Abuse Hotline for child protective investigation, children that are included in protective investigations, children that receive services, child removal rates, and children entering and leaving out-of-home care. The home page will be updated by the 15th of each month and show the latest 24 months of child welfare information.

Included in this 1st release of the Child Welfare Dashboards are five more child welfare trend reports, updated monthly, with current and historical information as far back as 2003. The five other dashboards are:

1. **Children & Young Adults Receiving In-Home Services** dashboard provides the count of children and young adults receiving in-home services as of the end of each month displayed.

2. **Children Entering Out-of-Home Care** dashboard provides the count of children entering out-of-home care during each month displayed.

3. **Children in Out of Home Care** dashboard provides the count of children in out-of-home care as of the end of each month displayed.

4. **Children and Young Adults Exiting Out-of-Home Care** dashboard provides the count of children (ages 0-17) and young adults (age 18 only) exiting out-of-home care during each month displayed.

5. **Removal Rates per 100 Alleged Victims** dashboard provides the rate of children removed per 100 alleged victims in investigations closed during each month displayed.

Users can customize their experience by service area, by dates, and through a series of available demographic filters. In addition, from the Data Table tab, users can extract all underlying data to a spreadsheet format to continue exploration of data offered.

The release of these dashboards marks a major achievement in the Department's Child Welfare Results-Oriented Accountability (ROA) implementation initiative. Through ROA, the Department of Children and Families aims to improve access to good quality data, build analytical capacity of staff to use data, take action to improve outcomes, and continue to develop a results-oriented culture of shared accountability, transparency and collaboration with a focus on research and evidence-based interventions. These child welfare dashboards marks the first of a series of releases. Future releases will include child protective investigation views, safety methodology views, CBC Views, Child Welfare Practice drivers, Child Welfare Outcomes, and Florida Continuous Quality views.

SUPPORTING INFORMATION:

- The Results Oriented Accountability Interactive Child Welfare Dashboards are developed and published using Tableau software. **The dashboards are best viewed using Google Chrome web browser. If you use an older version of Internet Explorer an error will be displayed.**
- As the new Child Welfare Dashboards provide data consistent with the Child Welfare Services Trend Report, as well additional data elements, and allows for interactive downloading of selected data, the Child Welfare Services Trend Report will be sunset no later than May 15, 2017. The Child Welfare services data will now be available for download from the Child Welfare Dashboards from the Data Table Tab on each dashboard. There is also a Methodology Tab on each dashboard that explains the detailed methodology and business rules related to the generation of the data. For staff that need to use the Child Welfare Services Trend Report to complete any projects through the end of SFY 2016-

2017, this report will be run and packaged for SFY 2016-2017, and will be available upon request. It is important to note that due to different run dates, the data in the Child Welfare Services Trend Report will not match the data in the Child Welfare Dashboards.
