



## FSFN TIP SHEET: Title IV-E Eligibility Automated Redeterminations v. 11/2019

**Automated Redeterminations** will be generated by FSFN in various scenarios. Those scenarios are as follows:

- When an Out-of-Home placement is approved documenting a child moving from a non-licensed placement to a licensed placement.
- When an Out-of-Home placement is approved documenting a child moving from a licensed placement to a non-licensed placement.
- Regarding Reasonable Efforts to Prevent Removal, when Question 4 on the Initial tab of the Title IV-E Eligibility Determination page is Yes and the date entered indicating the effective date of the judicial finding is not in the same month and year as the Removal Begin Date, upon completion of the Initial Determination, FSFN will automatically create and complete a Redetermination row to update eligibility. \*\*This does not apply to Title IV-E pages flagged as EFC.
- Regarding Reasonable Efforts to Finalize Permanency Plan, at the 14<sup>th</sup> month from the IV-E Removal Date or most recent Redetermination Question 4 Date and a Redetermination has not been completed with Question 4 as NO, FSFN will systematically generate a Redetermination row with Question 4 = No and the Effective Date of row = 1st day of 13<sup>th</sup> month. This means that if a Redetermination has not been documented at the 14<sup>th</sup> month following the Redetermination Q4 Date, a Redetermination will be system generated to update eligibility to Non-Reimbursable. \*\*This does not apply to Title IV-E pages flagged as EFC.
- Regarding Best Interest to remain in care for Voluntary removals, at the 181<sup>st</sup> day from the VPA date documented on Initial tab of the Title IV-E Eligibility Determination, if the Initial is completed with a Pending Judicial Finding for Question 5B and Question 2 on the Redetermination is not completed as Yes, FSFN will autogenerate a Redetermination as Ineligible and use the effective date as the 181<sup>st</sup> day from the Date of VPA on the Initial tab.
