FSFN Quarter 3 Release

PURPOSE: The purpose of this memorandum is to inform all stakeholders of the status of the implementation of the Florida Safe Families Network (FSFN) functionality to support House Bill 7013 (Adoptions and Foster Care), which became law on July 1, 2015. Final preparations should be made locally to "Get Ready" for the upcoming changes.

House Bill 7013 (http://laws.flrules.org/files/Ch 2015-130.pdf) created four new adoption incentive programs. These programs are: Adoption Incentive Benefits for State Employees and Other Applicants, Community Based Care Incentive program, Post Adoption Communications program, and the annual Adoption Achievement Award. With the creation of these programs, the Department of Children and Families (DCF) and our Community-Based Care (CBC) partners must meet specific documenting and reporting requirements. To meet these new documenting and reporting requirements, it is necessary to update the functionality of FSFN and all pertinent policies and procedures. These new statutory changes and programs will provide additional support for adoptive families and assist these families in reaching and preserving permanency.

BACKGROUND: The functionality enhancements for the Adoption Incentive project are the following:

- Creation and documentation of a New Post Adoption Services page
- The ability to document Post Adoption Service Referrals
- New Expressed Intent box
- Additional recruitment adoption events added
- Ability to track the amount of money spent on recruitment events
- Four new values will be added to "Meetings type"
- Post Adoption Services types (paid and unpaid) will now be available via a drop down box
- o A new Post Adoption Case Note Category
- New Post Adoption Case Types
- Ability to document 'Non Face-to-Face contacts' on case notes
- Improved Unified Home Study Search (Expired)

ACTION REQUIRED: Review and identify any needed changes to local business processes such as; post adoption communication with adoptive families, documentation of recruitment activities, documentation of post adoption services, and adoption information page data entry. Once changes are identified, implement changes as needed and distribute to those who work with adoptive families in the child welfare system.
