## **INFORMATIONAL MEMO**

PURPOSE: This memorandum is to inform all stakeholders of the current status of the upcoming Adoption Enhancements that are set to "go live" on April 1, 2016. This memo also provides training and informational resources so that final preparations can be made within your local area to "Get Set" for new functionality changes.

BACKGROUND: In preparation for the launch of this new functionality on April 1, there has been a continuous effort to communicate frequently with those who will benefit from these new system changes and to ensure adequate support is available after the changes take effect. The following is a status update on our readiness assessment:

SYSTEM READINESS: Ready! FSFN User Acceptance Testing was completed as scheduled on March 15, 2016.

**PEOPLE READINESS:** Ready! Regional trainings were completed throughout the state this week. Each Region's Points of Contact have also received training plans from their respective Community Based Care (CBC) Lead Agencies. These training plans were developed to outline the strategies the CBC will use to train staff on new policies and FSFN functionality.

POST-DEPLOYMENT SUPPORT READINESS: Ready! Daily triage calls will be held at 4 p.m. EST for the two weeks following "Go Live" to support incoming issues related to FSFN functionality. The post-implementation support team will include the Office of Child Welfare, the Office of Information Technology Services, IBM, the Regional Points of Contact, and the CBC Adoption Champions.
