




CHAPTER 3: TANF

SECTION 3-5: FSFN DOCUMENTATION

THE 'TANF ELIGIBILITY DETERMINATION DUE' REPORT IN FSFN MUST BE UTILIZED BI-WEEKLY, AT MINIMUM, TO IDENTIFY CASES WHICH REQUIRE THE COMPLETION OF A TANF ELIGIBILITY DETERMINATION.

- ❖ TANF determinations should not be completed for ICPC cases.
 - ❖ A Legal Record must be created and a Legal Action Initiated of 'Custody of Other State – Begin' with a Legal Custody Status as 'Custody of Other State' to prevent the case from appearing on the Report.

WHEN IS A TANF REQUIRED?

Case TANF Initial

1. New Living Arrangement episode.
2. Discharge from out-of-home Placement to Living Arrangement and an active TANF does not exist.
3. First occurrence in a Removal Episode in which the Placement has a Service Category of 'Relative' or 'Non-Relative' OR the Service Category is 'Foster Home' w/ a Placement Setting of 'Relative' and child is IV-E Ineligible.

Case TANF Redetermination

1. If the child is TANF eligible, every 12 months while the child is living with a parent/relative (Living Arrangement), non-licensed relative (Placement), or licensed relative (Placement) if the child is IV-E Ineligible.
2. If the child is TANF ineligible and Placement or Living Arrangement changes to a parent or relative Placement or Living Arrangement.

Adoption TANF

1. When Adoption Eligibility is approved as 'Ineligible'.
2. If the child is TANF eligible, every 12 months with an active 'Adoption' service.
3. Child relocates from Florida to another state or another state to Florida.
4. Child has an income (earned or unearned) change.

GAP TANF

1. Initiated upon request for eligibility identification for GAA when a child is IV-E Foster Care Ineligible. Effective From date must match Effective Date/Date of Agreement on GAA.
2. If the child is TANF eligible, every 12 months with an active 'Guardianship' service.
3. Child relocates from Florida to another state or another state to Florida.
4. Child has an income (earned or unearned) change.



CHAPTER 4: TITLE IV-E FOSTER CARE SECTION 4-8: FSFN DOCUMENTATION

THE 'TITLE IV-E ELIGIBILITY DETERMINATIONS DUE' REPORT IN FSFN MUST BE UTILIZED ON A MONTHLY BASIS, AT MINIMUM, TO IDENTIFY 'INITIAL' AND 'REDETERMINATIONS' THAT ARE UPCOMING AS DUE.



WHEN IS A TITLE IV-E REQUIRED?

Initial

1. Every Removal Episode regardless of out-of-home Placement type.

Redetermination (Eligible Children/Young Adults Only)

2. To document finding of Best Interest within 180 calendar days. (*User entered*)
 - This is required for Voluntary removals.
 - If not documented by the 181st day, FSFN will generate a Redetermination with Question 2 as 'No' and an eligibility status of Ineligible.
3. To document finding of Reasonable Efforts to Finalize Permanency Plan at least every 12 months. (*User entered*)
 - This is required for Court Ordered removals regardless of Placement type or Reimbursability status.
 - If not documented by 14th month, FSFN will generate a Redetermination with Question 4 as 'No' and an eligibility status of Not Reimbursable as of 13th month.
4. Change in SSI benefits - beginning or ending. (*User entered*)
5. Placement change between Reimbursable and Not Reimbursable placement settings. (*Currently user entered. FSFN automated in June 2022*)
6. Placement in a Non-Specified Setting CCI longer than 14 days. (*Currently user entered. FSFN automated in June 2022*)
7. Suitability assessment not completed prior to or within 30 days from the start of the QRTP placement. (*Currently user entered. FSFN automation planned*)
8. Court has not reviewed the QRTP placement prior to or within 60 days from the start of placement. (*Currently user entered. FSFN automation planned*)
9. QRTP placement continues 30 days after not approved/recommended. (*Currently user entered. FSFN automation planned*)

ONGOING TITLE IV-E ELIGIBILITY DETERMINATIONS

- (1) WHEN A CHILD IS PLACED IN A FFPSA NON-SPECIFIED SETTING CCI PLACEMENTS AS OF THE 15TH DAY OF A CHILD'S PLACEMENT, A REDETERMINATION MUST BE COMPLETED TO REFLECT AN 'ELIGIBLE, NOT REIMBURSABLE' ELIGIBILITY STATUS.
- (2) AS OF THE 1ST DAY OF A CHILD PLACED IN A QRTP WHEN THE 30-DAY ASSESSMENT (SUITABILITY) BY A QUALIFIED INDIVIDUAL WAS NOT COMPLETED WITHIN 30 CALENDAR DAYS OF THE START OF THE PLACEMENT, A REDETERMINATION MUST BE COMPLETED TO REFLECT AN 'ELIGIBLE, NOT REIMBURSABLE' ELIGIBILITY STATUS.
- (3) AS OF THE 61ST DAY OF A CHILD PLACED IN A QRTP WHEN THE COURT HAS NOT APPROVED THE PLACEMENT WITHIN 60 CALENDAR DAYS, A REDETERMINATION MUST BE COMPLETED TO REFLECT AN 'ELIGIBLE, NOT REIMBURSABLE' ELIGIBILITY STATUS.
- (4) AS OF THE 31ST DAY OF A CHILD PLACED IN A QRTP AFTER THE 30-DAY ASSESSMENT DETERMINES THE PLACEMENT IS NOT APPROPRIATE, COURT DISAPPROVES THE PLACEMENT, OR A DETERMINATION, MADE BY THE MULTI-DISCIPLINARY TEAM, THE CHILD IS TO BE REUNIFIED OR PLACED WITH RELATIVE, LEGAL GUARDIAN, ADOPTIVE PARENT, OR FOSTER FAMILY HOME, A REDETERMINATION MUST BE COMPLETED TO REFLECT AN 'ELIGIBLE, NOT REIMBURSABLE' ELIGIBILITY STATUS.





FSFN AUTOMATION – COMING JUNE 2022!

FSFN ENHANCEMENT: NON-SPECIFIED SETTING PLACEMENTS THAT EXCEED 14-DAY LIMIT

- Every night, FSFN will look at all 'Reimbursable' children, ages 0-17, in OOH placement that began 20 days prior and determine if the placement is a Non-Specified Setting based on the licensure of the Provider ID.
- FSFN will assess if Q6A would result in a 'No' and Q6B would result in a 'Yes'.
- If so, a redetermination row will be generated on the IV-E Foster Care Eligibility page with an 'Effective From' date as of the 15th day.
 - Days while on runaway, visitation, or hospitalization count towards 14-day calculation.
 - Consecutive placements with the same provider do not restart the clock.






FSFN AUTOMATION – COMING JUNE 2022!

FSFN ENHANCEMENT : PLACEMENT CHANGES

Current Functionality: Automation occurs for placement changes between a licensed setting and non-licensed setting and vice versa.

New Functionality: Automation will occur for every OOH placement entry regardless of any other factor.
