Commission Update and Review of 2024 Children and Youth Subcommittee Areas of Focus

Commission Chair Jay Reeve provided a brief Commission update while alluding to the positive feedback received regarding the second interim Commission report. This subcommittee shall continue to focus on the school and community provider interface. Subcommittee will also expand its charge to consider child and youth treatment within the community to include Community Action Teams, children's baker act services, outpatient and inpatient options focusing on expansion of treatment options showing positive outcomes. Subcommittee work should be supportive of future recommendations for the next report.

Subcommittee Chair Hunschofsky identified potential deficiencies within the behavioral health system of care brought to the attention of the Legislature including but not limited to, community resource disparities, mobile response service and crisis stabilization services for youth.

Open Call for Subcommittee Presentations/Speakers

Subcommittee Chair Hunschofsky requests all Children and Youth subcommittee members receive invites to all Commission on Mental Health and Substance Use Disorder subcommittee meetings.

Suggested presentations include:

- The awareness within school systems regarding the availability of behavioral health services and how to access those service. We want to understand why students are going to the emergency room instead of community providers and what can be done to mitigate this so the students are

The presentation shall cover: the internal structure within the education system for communicating from the district mental health coordinator down to the family as well as the way in which community behavioral health providers interface with schools. - Overview from a Community provider perspective presentation regarding the challenges surrounding communication and building relationships with schools. Presentation that address the gap in services during the transition from juvenile mental health services to the adult system. - Presentation from a sample of counties and districts that implemented a successful school and community behavioral health program.
