Subcommittee chairs were appointed by the Commission Chair and serve at the pleasure of the Chair and have been provided the authority to identify and examine current methods, practices, and procedures of providing behavioral health care and to make recommendations to the full commission that will improve the effectiveness of the service delivery and outcomes for those receiving behavioral health services. The Chairs formed workgroups comprised of subject matter experts from various disciplines to provide assistance with accomplishing these tasks. Workgroup members are not required to be a member of the full commission but must be subject matters experts in their respective fields and be willing to lend their expertise to enhancing preexisting services and supports, and to research innovative tools and ideas that may transform the behavioral healthcare system.
