# Message from Secretary Harris

*At the Florida Department of Children and Families, we are grateful for the opportunity to serve the people of Florida, and we are steadfastly committed to continuously enhancing policies and processes to meet Floridians' needs. Tracking progress at critical points in the process allows for collaboration with key stakeholders to continuously improve the services and resources with the greatest positive impact. Florida's child welfare system has experienced unprecedented support under the leadership of Governor Ron DeSantis, resulting in the implementation of powerful new programs and increased access to initiatives that have proven success in the state.*

*As part of the Department's continuous quality assurance efforts, we track and quarterly review previously established accountability and performance metrics, engaging with our community-based lead agencies, which provide child welfare services in local communities, to maximize outcomes for our state's children and families.*

*With this annual report, I am pleased to share that during Fiscal Year (FY) 2023-2024, Florida continues to lead the nation in investigative response times and surpasses national averages in safety and risk concerns for children, as well as in providing services to prevent entry into foster care.*

*Together with our partners, Florida is significantly outperforming established standards and national averages for safety metrics with 88 percent of the state's judicial circuits meeting or exceeding expectations, including the percentage of children not experiencing recurrent maltreatment within 12 months of a verified incident, the rate of children not abused while in in-home care, and the incidence of abuse in out-of-home settings.*

*Over the last three years, the Department has been laser-focused on working upstream, with the goal of connecting at-risk families to the care they need to limit or avoid their involvement with the child welfare system. We continued to make impressive strides toward that goal during FY 2023-2024, resulting in a 37 percent decrease in removals compared to FY 2020-2021. This accomplishment is only made possible through the enhanced prevention programs and initiatives that have been implemented across the state to support our most vulnerable families.*



*Alongside the decrease in the rates of removal of children from their homes, the ratio of children exiting out-of-home care compared to those entering has improved. In FY 2023-2024, exits from out-of-home care exceeded new entries by 24 percent — a significant improvement from the previous three years, where entries outpaced exits by an average of 2.93 percent.*

*In addition to the improved exit ratios, we have seen reductions in the time taken to achieve permanency. The statewide performance for percentage of children reaching permanency within 12 months of entering out-of-home care has increased by nearly three percent. Furthermore, the percentage of children achieving permanency within 12 to 23 months of entering out-of-home care has improved by nearly seven percent. While we still have work to do to meet and exceed all targets, these accomplishments are directly linked to innovative initiatives, such as the Permanency Pilot, which was instrumental in reducing bureaucratic red tape in the child welfare system and opening the path for expedited reunifications and adoptions. While we are encouraged by these highlights, we are also committed to addressing – alongside our partners – identified areas for improvement, so together we may maximize our potential.*

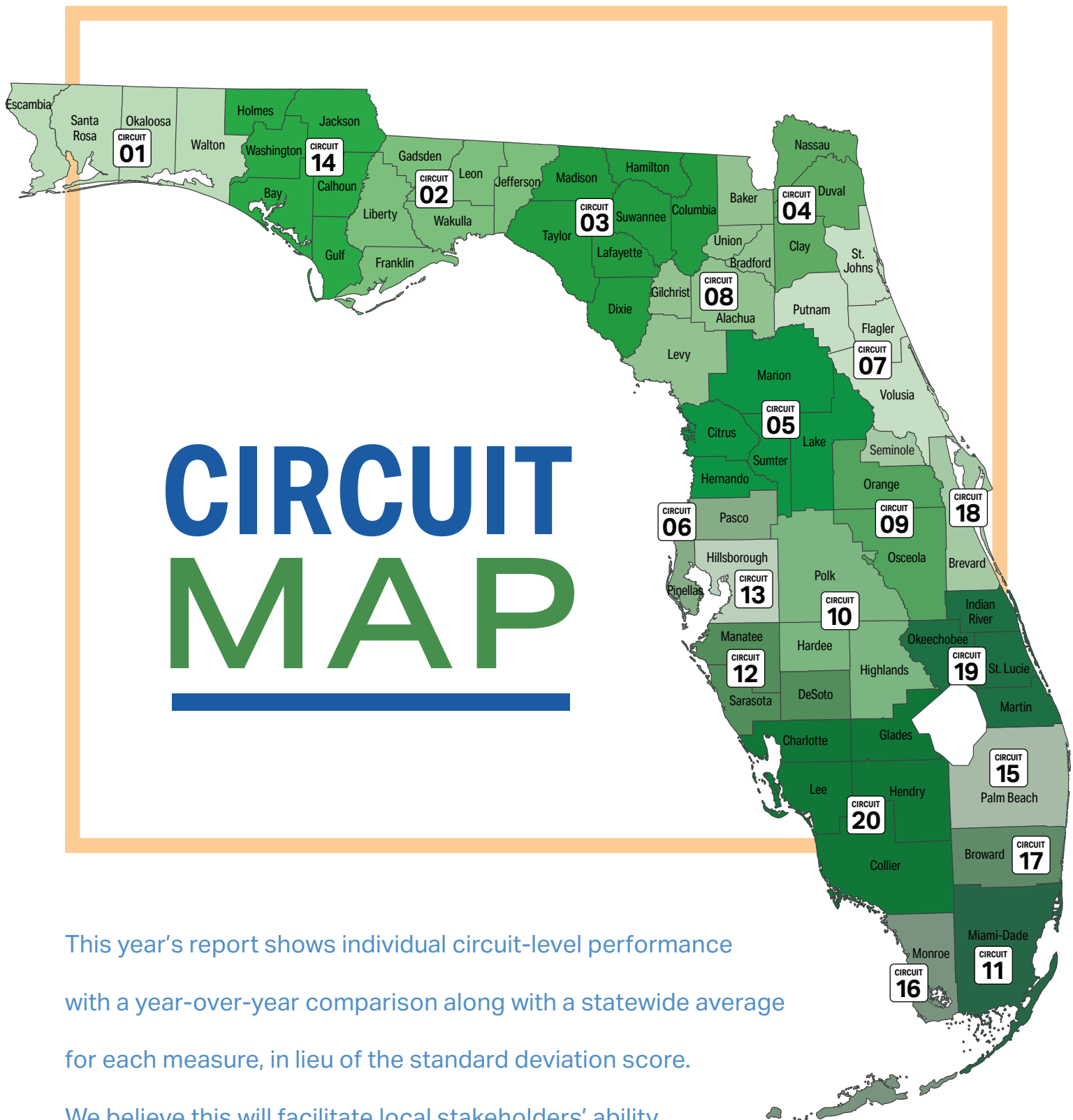

# Appendix 1: Methodology

## Metrics

Metrics included in the accountability system focus on child and family outcomes and the quality of services provided by each practice area within a circuit. There is a total of 13 accountability metrics, which have been established across the domains of permanency, safety, and well-being. Three of the accountability metrics are qualitative index measures, representing the percent of all qualitative standards met within each domain.

Each metric has been clearly defined with standard levels of quality prescribed. The majority of measures and performance standards are aligned with federal standards. For the three state-specific metrics without pre-established federal standards, standards were established based on historical statewide performance.

A complete listing of the accountability metrics is provided in Appendix 2 of this report, and a complete listing of the qualitative standards included in the qualitative index scores is provided in Appendix 3 of this report.

In addition to the accountability metrics, provided alongside each of the circuit scores throughout this report is data on relevant contextual factors. While these factors are not a part of the methodology used to score circuit health, they are highly relevant to understanding and interpreting performance on the accountability metrics. The contextual factors considered throughout this report include the following: numbers of total population and the population under age 18; numbers of investigations, removals, and removal rates; numbers of children receiving services, entering care, exiting care, and entry rates; and rates for unemployment, graduation, suicide, and poverty. Circuit-specific and statewide data is provided for each of these contextual factors.

## Data Sources

The Florida Safe Families Network (FSFN) is the data source for all quantitative measures, and the data source for all qualitative metrics is the Qualtrics Life of Case Tool, which collects the results of the quality reviews conducted by the Department's Quality Office. Quality reviews were established based on standards outlined in federal Child and Family Services Reviews (CFSR), Florida Statute, and the Department of Children and Families Operating Procedures (CFOP).

Reviews are conducted across the lifecycle of a case to allow for near to real-time feedback and to provide supervisors opportunities to discuss or contest findings. Reviews are conducted using a representative, random population sample at a volume to provide results at 90 percent confidence with a 10 percent margin of error, by circuit. Additionally, the Department has deployed a quarterly "Benchmarking" process to ensure the inter-rater reliability and agreeability of findings. The results of this process have shown the quality review findings to be above industry standards for reliability.

## Scoring

This report provides data reflecting the performance of circuits over the twelve months of State Fiscal Year (FY) 2023-24. The methodology for evaluating circuit performance was updated in FY 2023-24 to focus on year-over-year improvements within each circuit. Upward, downward, and inward-facing arrows are used to represent the performance trends across the domains of permanency, safety, and well-being, indicating whether most metrics showed improvement, did not show improvement decline, or remained unchanged compared to FY 2022-23. This approach fosters a culture of continuous quality improvement by recognizing progress and areas for growth.
