Regional Collaboratives Update:

Asta Trinh, Director of Regional Operations and Initiatives, with the DCF-Office of Substance Abuse and Mental Health, provided an update on the development of regional collaboratives to strengthen community networks and cross-agency collaboration. House Bill 7021 created section 394.90826, F.S., requiring the DCF and the Agency for Healthcare Administration to establish Behavioral Health Interagency Collaboratives throughout the State. All six regional collaboratives have been established and meetings will begin in February 2025.

Update on Legislative Action on 2025 Commission Recommendations:

Senator Darryl Rouson provided an update on his drafting of a bill that incorporates several recommendations contained within the January 1, 2025 Annual Interim Commission Report. Representative Christine Hunschofsky will sponsor the House version of the Bill.
