#### SWFL REFUGEE TASK FORCE MEETING MINUTES

This meeting was held at the Department of Children and Families in Fort Myers. Janet Blair, Community Liaison, represented the Dept. of Children & Families (DCF). Nineteen people were present and the meeting was called to order at 1:10.

## **PRESENTATIONS**

- The first presentation was given by Don Jarrell of United Stated Citizenship and Immigration Services (USCIS). He passed out Public Charge Fact Sheets and shared that there are now 8 new online forms at the USCIS website. Clients are urged to learn to navigate the site as the goal is for USCIS to go completely paperless in the near future. Shelly Randall, Field Office Director of the USCIS Fort Myers branch, shared that the office is now fully staffed. The Fort Myers office has been up and running for 3 years now and processing times are steadily declining. Shelly did stress that it is important for clients not to apply for citizenship prior to studying for the exam. Since applications are now taking less time to process, clients should be prepared to take the test prior to submitting their application.
- The second presentation was given by Denise Garbin from DCF Economic Self-Sufficiency (ESS). Denise is the Operations and Management Consultant (OMCI) and oversees the Refugee Assistance Program (RAP) Unit for the region. She went over new income guidelines that are effective as of October 1st of this year. She also announced that all ESS staff are now cross trained in administering RAP as of Oct. 1st and shared that as of May 1st there will be a change statewide that no clients will have expedited food assistance without an interview being conducted first.
- The final presentation was given by Ahmed Khan from Council on American-Islamic Relations (CAIR). There is now a Fort Myers CAIR office and all services are offered pro bono. Clients can be assisted with immigration documentation, school bullying issues, know your rights clinics and family law. More information can be found at https://www.cairflorida.org/

### DCF, PROVIDER & COMMUNITY UPDATES

- Janet Blair presented a Power Point on working with Child Support Enforcement.
- Lutheran Services, Florida's SWFL Comprehensive Refugee Services program shared that
  they are launching a new mentor program. An event will be held next week to recruit youth
  and young adults for the program which serves those ages 15-24. This program will be
  available in Sarasota, Lee and Collier counties. The Sarasota office will be moving in
  February to another location.
- Collier County Health Department was represented by Sharon Paterson who shared that they are seeing an increase in Haitian arrivals. They have seen 283 individuals so far this

year in the Refugee Clinic.

 Nirupa Netram, Director of Foundation & Legal Operations Southwest Florida Community Foundation, announced that the next immigration learning community meeting will be held on Feb. 13<sup>th</sup>, 2020. This is a wonderful networking opportunity for those working with immigrants in the area. All meetings are held in Fort Myers and more information can be found at www.floridacommunity.com
