SCOPE

INITIAL REQUEST & ASSUMPTIONS

Business Statement

DCF and the submitting entities require the undo delete function be removed from FASAMS.

Scope Definition

FEI will remove the code that controls the undo delete function from FASAMS. FEI will create a new error message that will display when a user submits an undo delete XML file. Finally, FEI will update the FASAMS code to allow a user to submit a record with the same SRI as a record that has previously been deleted. FEI will update the Pamphlet 155-2 to remove all undo-delete verbiage throughout.

EXISTING FUNCTIONALITY

FASAMS allows users to delete a record and then undo that deletion with an undo-delete action in XML. Users are not allowed to submit a record with an SRI that is the same as a previously deleted record or they will receive an error.

PROPOSED FUNCTIONALITY

FASAMS will not allow users to undo-delete a record that was previously deleted. Any deleted records will be marked as deleted in the system and it will not be possible to make them active again. FASAMS will allow users to submit a record with the same SRI as a previously deleted record without generating an error. FASAMS will show an error if a user submits an undo-delete XML file which will inform them that the undo-delete action is not accepted by FASAMS.
