# **INITIAL REQUEST & ASSUMPTIONS**

#### **Business Statement**

DCF and the DAC Subcommittee has identified the Treatment Setting codes as one of the primary issues in FASAMS currently. As such, DCF has decided to remove Treatment Settings and their codes from the entire FASAMS system. This will allow the managing entities to more easily submit data to the system and decrease the number of data validation errors. With the removal of the PoviderSiteTreamentSetting entity, the ProviderSiteProgramArea and ProviderSiteCoveredService entities will be restructured in the database to make the ProviderSiteCoveredService the child of ProviderSiteProgramArea. This structure aligns with the business processes currently used my managing entities.

# Scope Definition

This enhancements will remove the ProviderTreatmentSetting entity as a subentity of ProviderSite and will realign ProviderSiteProgramArea as a subentity of ProviderSite and ProviderSiteCoveredService as a subentity of ProviderSiteProgramArea.

# Assumptions, Constraints, Dependencies

There is an assumption that all data set changes for FASAMS version 14 will be completed together and deployed to FASAMS production on 8/1/2020.



# **EXISTING FUNCTIONALITY**

Currently, ProviderTreatmentSetting is a subentity of ProviderSite, ProviderTreatmentSettingCoveredService is a subentity of ProviderTreatmentSetting, and ProviderTreatmentSettingProgramArea is a subentity of ProviderTreatmentSettingCoveredService.

# **PROPOSED FUNCTIONALITY**

The Provider data set will be restructured to support the removal of the ProviderTreatmentSetting subentity. The following will occur to achieve this restructure:

- ProviderTreatmentSetting subentity will be removed from data set
- ProviderTreatmentSettingProgramArea
  - o Becomes subentity of ProviderSite
  - o Is renamed to ProviderSiteProgramArea
- ProviderTreatmentSettingCoveredService
  - Becomes subentity to ProviderSiteProgramArea
  - Is renamed to ProviderSiteCoveredService
