SCOPE

INITIAL REQUEST & ASSUMPTIONS

Business Statement

DCF and the DAC Subcommittee has identified the Treatment Setting codes as one of the primary issues in FASAMS currently. As such, DCF has decided to remove Treatment Settings and their codes from the entire FASAMS system. This will allow the managing entities to more easily submit data to the system and decrease the number of data validation errors. To achieve this, Service Events will now point to a specific PlacementRecord already set up under a Treatment Episode, instead of an Admission with a Treatment Setting, for their Service Event submission to succeed. Therefore, the TreatmentSettingCode field will be removed from the data set. Finally, the DAC has also identified that TreatmentLocaleCode should be included in this data set.

Scope Definition

This enhancement will include the addition of the following fields, PlacementRecordSourceRecordIdentifier, PlacementRecordProviderSourceRecordIdentifier, TreatmentLocaleCode. The TreatmentSettingCode field will be removed from this data set.



Assumptions, Constraints, Dependencies

There is an assumption that all data set changes for FASAMS version 14 will be completed together and deployed to FASAMS UAT on 6/1/2020.

EXISTING FUNCTIONALITY

Currently, users are expected to submit TreatmentSettingCodes that must match the admission against which the service event is being submitted.

PROPOSED FUNCTIONALITY

Once this enhancement has been implemented, end users must submit PlacementRecordSRIs with the Service Event submission for a PlacementRecord already set up under a TreatmentEpisode.Admission. Users will be required to submit TreatmentLocaleCodes and will no longer be able to submit TreatmentSettingCodes in the Service Event data set.
