SCOPE

INITIAL REQUEST & ASSUMPTIONS

Business Statement

During implementation of FASAMS, it was determined that the outcome measure targets for the Managing Entities could not be obtained from the IDS or CARS systems. The data was stored as text and not as individual data elements that could be obtained via an interface. The targets are needed in order to provide reporting on ME performance.

Scope Definition

The scope of this enhancement is to allow submitting entities to submit an XML data set that will include the target outcome and output measures for the submitting entity's current contract.

Assumptions, Constraints, Dependencies

• This enhancement does not include new validation rules for Subcontract based on targets submitted in the Contract XML

EXISTING FUNCTIONALITY

FASAMS currently interfaces with IDS to populate the Contract module with submitting entity contract data. The interface is unable to pull in Target Outcome Measure because of the way they are stored in IDS, so Target Outcome Measures are not populated in FASAMS.



PROPOSED FUNCTIONALITY

FASAMS will accept a new dataset for Contract outcome targets that closely replicates the Subcontract dataset. The dataset will use many of the same rules and key fields as Subcontract dataset with those removed that do not apply.

The Contract Compliance reports will be updated to include the Contract targets if they have been submitted by the MEs. Contract targets will be omitted on report if the target is not included in subcontract between ME and provider.

	1) The name of the data set must be the first word in the file, followed by an underscore.		
	2) The filename must be unique in the submitters set of currently uploaded and unprocessed		
	files.		
	3) The file must end with ".xml".		
	In order to satisfy requirement #2 above, it is suggested to append the date and time to each file after		
	the underscore, using the YYYYMMDDHHMMSS format.
