SCOPE

INITIAL REQUEST & ASSUMPTIONS

Business Statement

DCF requests the consolidation of FASAMS versions into a single database to support SAMH’s reporting needs and facilitate data migration into a future system.

Scope Definition

FEI will consolidate the FASAMS versions into a single database.

Due to the large scope of this enhancement, the requirements are split into two parts and deployed over two consecutive releases. The requirements here include **Part 2** of the enhancement, encompassing all tasks following the data migration.

Part 2 Scope:

FEI will complete the following post-migration tasks.

- Support file submissions with or without “Version14” in the file name
 - All files submitted will be processed with the “Version14” job processor and stored in “Version14” database
 - Note: Database will be stripped of “Version14” designation following this enhancement
- Remove “Version14” from Version 14 database schema names
- Update all impacted extracts and task services that look for “Version14” specific tables
- Decommission the reporting database
 - Remove Reporting Database ETL from code
 - Remove all Reporting Database tables
 - Remove grant access to Reporting Database role and permission from UI
- Remove Version 13 TEDS temp tables and ETL processes
 -
- Remove all references to “Versions” in the system
 - Remove Version 13 database
 - Remove V13 as a parameter from all reports where Version can be selected.
- Update Rules Configuration Tab in UI
 - Remove Version 13 data sets from Rules Configuration screen in UI
 - Remove Version 14 from V14 data set names
- Create snapshot of FASAMS Production prior to removal of tables or data from the system
 - Including Jobs tables and Staging tables

Assumptions, Constraints, Dependencies

1. This is **Part 2** of a two-part enhancement.
2. Implementing this change will introduce duplicate data into the system.
3. No file submission will ever be processed by the Version 13 job processor in the future.
4. The FASAMS Reporting Database will no longer exist.
5. FASAMS will no longer have two (2) MCI interfaces, only one (1).
6. The Jobs and Staging tables will not be migrated from the Archive or Version13 into Version14.
 - a. The Version13 Jobs and Submission tables will naturally be eliminated as part of Requirement 5, “Remove References to ‘Version13’”
7. These changes will not require any updates to the interfaces from DCF or AHCA agencies

EXISTING FUNCTIONALITY

There are currently three (3) versions of FASAMS that DCF SAMH staff uses for reporting: V13 Archive (Snapshot), Version 13 database, and Version 14 database.



PROPOSED FUNCTIONALITY

FEI will consolidate records from Archive and Version 13 into current Version 14. In Part 1, only the migration of data will occur. The removal of references to “Version14” in tables, file names, and rules will occur in Part 2. Updates to task services will also occur in Part 2.

DEVELOPMENT & TESTING NOTES

The following questions arose during database development. The questions and corresponding answers are here for reference.

1. QUESTIONS & ANSWERS FROM DATABASE DEVELOPMENT PHASE

ID	Description
Q1	<p>The schema names (not table names) have Version14 in the name. Do they want the schema name to be without "Version14"?</p> <p>Answer: Yes, DCF wants the schema to be without Version14.</p>
Q2	<p>[From BA] Should we do a snapshot of Production after the migration, before any old records (potentially) get changed?</p> <p>Answer: Yes, we want a snap shot before any tables/data is removed. Snapshot should include Jobs and Staging tables</p>
Q3	<p>How will reports change (not the reporting database, but SSRS reports and the existing SSAS)? Ex: we have a client search report where one parameter is the version. The parameter is hard-coded, so if we only want Version 14 to appear I need to remove the V13 option.</p> <p>Answer: We will add to the requirements: Remove V13 as a parameter from all reports where Version can be selected. This will be part of Enhancement 584841</p>
Q4	<p>Will SubcontractVersion14Module_UpdateSubcontractAssociationsForAmendments be removed once the final consolidation is complete?</p> <p>Answer:</p> <p>Can we remove the piece of code that tracks what version providers submitted for each dataset (ex: where we tracked if a provider deleted all Version14 ServiceEvent then they could go back to Version13)?</p> <p>Answer: Confirmed. That code can be removed</p>
