NUMERICAL AND SUBJECT INDEX TO ADMINISTRATIVE PUBLICATIONS

- 1. <u>Purpose</u>. This operating procedure furnishes current indexes of statewide administrative publications.
- 2. <u>Scope</u>. The attached indexes include operating procedures (CFOPs) (formerly called regulations), and pamphlets (CFPs). Appendix A contains a list of statewide operating procedures, and statewide pamphlets are listed in Appendix B.
- 3. <u>Keeping the Indexes Up to Date</u>. If necessary, update the indexes with write-ins until new indexes are published. An updated copy of this operating procedure is published approximately three times per year.
